May kindly see the online property statements received from Sri Sunil Kumar Srivastava, Principal Judge, Family Court, Shahjahanpur regarding submission of statement of movable and immovable properties acquired/held by him or any member of his family for the financial years 2020-21 & 2021-22 in the prescribed proforma respectively to this Court for kind perusal and information as required by the Court.

In this connection, it is submitted that as per statement of movable and immovable properties for the financial years 2020-21 & 2021-22 of the officer concerned, details of income, deduction, savings investment and expenditure made by him are given below.

(1) In the financial years 2020-21 & 2021-22, Total income are Rs.71,65,181/- and total deductions/ repayment/ savings/ investment (for both the financial years) against GIS, GPF, Income Tax, Home loan, Insurance policies, PPF, RD and Sukanya Samriddhi Yojna are Rs.43,97,272/-. Thus, a sum of Rs.27,67,909/- was therefore available with him to meet out the household expenditure of his family consisting four members in both the financial years. And the balance of his savings bank account(s) has also been reduced for Rs.9,408/- this financial year from previous year's balance.

In this connection, it is submitted that the officer has already submitted his property statement upto the financial year 2015-16 which had already been seen by Hon'ble Mr. Justice M.C.Tripathi, the then Administrative Judge, Banda, placed in the misc. file of the officer. And for the property statements of the financial years 2016-18 & 2018-20, detailed office notes have been laid before Hon'ble Mr. Justice Saurabh Shyam Shamshery, Administrative Judge, Shahjahanpur Judgeship for His Lordship's kind perusal and orders on eService ID 4049 & 5863 respectively.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit his property statement for the financial years 2020-21 & 2021-22 in its next financial year i.e., 2022-23 upto March 2023. He has submitted movable and immovable property statements of the financial years 2020-21 & 2021-22 vide online dated 23.05.2024. As such, there is delay in submitting the property statement of the aforesaid financial years from the part of the officer for which he has stated that "Delay in furnishing property statement due to bonafide mistake and tenders his unconditional apology for this mistake. He will always remember in future.", mentioned in remark column of movable proforma.

May, therefore, if approved, property statements for the financial years 2020-21 & 2021-22 of Sri Sunil Kumar Srivastava, Principal Judge, Family Court, Shahjahanpur be laid before Hon'ble Mr. Justice Saurabh Shyam Shamshery, Administrative Judge, Shahjahanpur Judgeship for His Lordship's kind perusal and orders?
