

**Registrar(J)(Budget)**

May kindly see the online property statements received from Sri Vidya Bhushan Pandey, Additional District & Sessions Judge (F.T.C.), Raebareli regarding submission of statement of movable and immovable properties acquired/held by him or any member of his family for the financial year 2021-22 & 2022-23 in the prescribed proforma respectively to this Hon'ble Court for kind perusal and information as required by the Hon'ble Court.

In this connection, it is submitted that as per statement of movable and immovable properties for the financial years 2021-22 & 2022-23 of the officer concerned, details of income, deduction, savings investment and expenditure made by him are given below.

(1) In the financial years 2021-22 & 2022-23, Total income is Rs.57,83,173/- [income from salary & other allowances (including arrears & leave encashment) is Rs.53,20,153/-, interest on savings of Rs.43,020/- and rental income of Rs.4,20,000/-] and total deductions/ repayment/ savings/ investment (for both the financial years) against GIS, CPF, PPF a/cs, Income Tax, Insurance policies, NSC, SIP and the balance of his savings bank account(s) has been enhanced for Rs.4,66,886/- this financial year from previous year's balance, total of which is Rs.32,17,117/-. Thus, a sum of Rs.25,66,056/- was therefore available with him to meet out the household expenditure of his family consisting three members in both the financial years.

In this connection, it is submitted that the officer has already submitted his property statement upto the financial year 2017-19, which had already been seen offline by Hon'ble Mr. Justice Siddharth, the then Administrative Judge, Raebareli. And property statements for the financial years 2019-21, detailed note has been submitted before Hon'ble Mr. Justice Arvind Singh Sangwan, Administrative Judge, Raebareli Judgeship for His Lordship's kind perusal and orders on e-service 2585.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit his property statement of the financial years 2021-22 & 2022-23 in its next financial year i.e., 2023-24 upto March,2024. He has submitted movable and immovable property statements of the financial years 2021-22 & 2022-23 vide online dated 14.06.2024. As such, there is delay in submitting the same from the part of the officer for which he has stated (in his verbatim) that "With deep reverence and profound veneration, I would like to submit that the property statement for the year 2019-21 was expected to be submitted till 31.03.2022 but due to illness and regular treatment of my wife in Lucknow and Ghaziabad, I could not submit it timely and was submitted on 19.05.2022 with a delay of one and half month. For this with folded hand, I tender my sincere apology. In future I will be more attentive and cautious in timely submission of property statement. Further it is most respectfully urged that Today I am submitting the property statement for the financial year 2021-23 with a delay of two and half month. The statement was expected to be submitted till 31.03.2024 but recently my father (age 76), fell ill and due to my busyness in his regular treatment and follow up, I could not timely submit the same. For this, with folded hand, again I tender my sincere apology.", mentioned in his reply dated 13.06.2024 submitted in the statement of 2019-21.

May, therefore, if approved, property statements of the financial years 2021-22 & 2022-23 of Sri Vidya Bhushan Pandey, Additional District & Sessions Judge(F.T.C.), Raebareli be laid before Hon'ble Mr. Justice Arvind Singh Sangwan, Administrative Judge, Raebareli Judgeship for His Lordship's kind perusal and orders?
