May kindly see the online property statements received from Sri Asif Iqbal Rizvi, Additional District & Sessions Judge, Saharanpur regarding submission of statement of movable and immovable properties acquired/held by him or any member of his family of the financial years 2019-21 (2019-20 & 2020-21) in the prescribed proforma respectively to this Hon'ble Court for kind perusal and information as required.

In this connection, it is submitted that as per statement of movable and immovable properties for the financial years 2019-2021 (2019-20 & 2020-21) of the officer concerned, details of income, deduction, savings, investment and expenditure made by him are given below:

(1) In the financial years 2019-20 & 2020-21, total Gross income is Rs.32,49,159/- and total deduction/ repayment/ savings/ investment/ against GIS, PPF, NPS, Income Tax, Personal loan, Insurance policies and the balance of his savings bank account has also been enhanced for Rs.16,908/- this financial year from previous year's balance, total of which is Rs.11,22,913/-. Thus, a sum of Rs.21,26,246/- was therefore available with him to meet out the household expenditure of his family consisting four members in both of the financial years.

It is pertinent to mention here that his wife is also a Judicial Officer having annual income of Rs.12,89,855/- and Rs.19,20,820/- in the financial years 2019-20 & 2020-21 respectively.

In this connection, it is submitted that Officer has already submitted his property statement of the financial year 2016-17, which has been seen by Hon'ble Mr. Justice Piyush Agrawal, the then Administrative Judge, Mau placed in the Misc. file of the officer. And for the financial years 2017-19, a detailed online note has been laid before Hon'ble Mr. Justice Alok Mathur, Administrative Judge, Saharanpur for His Lordship's kind perusal and orders on eService ID P00010922021.

It is submitted that as per policy/Court's Circular letter, the officer has to submit his property statement for the financial years 2019-21 (2019-20 & 2020-21) in its next financial year i.e. 2021-22 upto March, 2022. He has submitted movable and immovable property statements of the financial years 2019-21 firstly vide online letter dated 25.06.2024. As such, there is delay in submitting the same from the part of the officer for which he has stated (in his verbatim) that *"It is submitted that due to work pressure, especially disposal of Action Plan Cases and my family responsibilities, I could not collate the necessary details for submission of property statement of the financial years 2019-21 on time. Consequently, the said statement could not be submitted on time. I sincerely apologize for the same. In future, I will try my best to submit the property statement on time. I, therefore request your good self that kindly place my property statement along with this explanation for delay before Hon'ble Court for its kind perusal"*, mentioned in attachment dated 25.06.2024.

May, therefore, if approved, property statements for the financial years 2019-21 (2019-20 & 2020-21) of Sri Asif Iqbal Rizvi, Additional District & Sessions Judge, Saharanpur be laid before Hon'ble Mr. Justice Alok Mathur, Administrative Judge, Saharanpur for His Lordship's kind perusal and orders?
