May kindly see the property statement online received from Sri Viresh Chandra, Additional District & Sessions Judge/F.T.C., Hapur regarding submission of statement of movable and immovable properties acquired/held by him or any member of his family for the financial year 2015-16 & 2016-17 in the prescribed proforma respectively to this Hon'ble Court for kind perusal and information as required by the Hon'ble Court.

In this connection, it is submitted that as per statement of movable and immovable properties for the financial years 2015-16 & 2016-17 of the officer concerned, details of income, deduction, savings investment and expenditure made by him are given below.

(1) In the financial years 2015-16 & 2016-17, Total income is Rs.19,43,486/- (total Gross income from salary are Rs.17,43,486/- and matured amount of KVP/STDR is Rs.2,00,000/-) and total deductions/ repayment/ savings/ investment (for both the financial years) against GIS, NPS, Income Tax, PF, Car loan and the balance of his savings bank account(s) has also been enhanced for Rs.1,02,327/- this financial year from previous year's balance, total of which is Rs.6,57,819/-. Thus, a sum of Rs.12,85,667/- was therefore available with him to meet out the household expenditure of his family consisting three members in both the financial years.

It is pertinent to mention here that his wife is Advocate having annual income of Rs.2,96,780/- approx.

In this connection, it is submitted that the officer has already submitted his property statement at the time of entering into judicial service which had already been seen offline by Hon'ble Mr. Justice D.K.Upadhyay, the then Administrative Judge, Bijnor, placed in the misc. file of the officer Property statement for the financial years 2009-11, 2011-13 and 2013-15, detailed online notes have been laid before Hon'ble Dr. Justice Yogendra Kumar Srivastava, Administrative Judge, Hapur Judgeship for His Lordship's kind perusal and orders on e-service IDs P00006302024, P00006312024 and P00006352024 respectively.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit his property statement of the financial years 2015-16 & 2016-17 in its next financial year i.e., 2017-18 upto March 2018. He has submitted movable and immovable property statements of the financial years 2015-16 & 2016-17 vide online dated 08.07.2024. As such, there is delay in submitting the same from the part of the officer for which he has stated (in his verbatim) that "he has already submitted his property Statement for the financial years ending on 31.03.2010, 31.03.2012, 31.03.2014 and 31.03.2016 at the time of posting as Civil Judge (J.D), Etah through letter/endt. No 2225/XV Civil/2016 dated 19.10.2016 of the District Judge, Etah, However, that not found sufficient by the Hon'ble Court and same query was made vide Hon'ble Court 's letter no. 1484 dated 30.01.2017, which has come to my knowledge through its reminder letter no 1654 dated 05.02.2024. In the event, the applicant has not been able to submit his subsequent property statement, which are due thereafter. Moreover In the year of 2017 I got transfered from Etah to Gautambudhnagar and during these time, elder brother of the applicant died in the year 2017 and also due to load of work and some family circumstances, delay in submitting the property statement occurs, for which the applicant seeks unconditional apology", mentioned in remark column of movable proforma.

In this connection, it is also submitted that officer has also submitted the property statement of the financial years 2016-18 & 2018-20 online on eService portal but blocks of statement are not correct. Hence, objections have been raised on the said statements for submitting the correct block. Therefore, these statements will be laid before Hon'ble Administrative Judge after reply by the officer.

May, therefore, if approved, property statements of the financial years 2015-16 & 2016-17 of Sri Viresh Chandra, Additional District & Sessions Judge/F.T.C., Hapur be laid before Hon'ble Dr. Justice Yogendra Kumar Srivastava, Administrative Judge, Hapur Judgeship for His Lordship's kind perusal and orders?
