May kindly see the property statement received online from Smt. Reeta Kaushik, Principal Judge, Family Court, Jaunpur regarding submission of statement of movable and immovable properties acquired/held by her or any member of her family for the financial year 2022-2024 (2022-23 & 2023-24) in the prescribed proforma respectively to this Court for kind perusal and information as required by the Court.

In this connection, it is submitted that as per statement of movable and immovable properties for the financial year 2022-2024 (2022-23 & 2023-24) of the officer concerned, details of income, deduction, savings investment and expenditure made by her are given below:

In the financial year 2022-2024 (2022-23 & 2023-24), the Gross income is Rs.1,45,58,809/- (Rs.1,32,38,564/- from salary & arrears and Rs.13,20,245/- from Interest on FDR & Saving A/c) and total deductions/repayment/savings/investment against GIS, GPF, PPF, Loan repayments and Income Tax are Rs.49,47,725/- and the balance of her savings bank account is also increased by Rs.85,69,960/- in this financial year from previous year's balance, total of which is Rs.1,35,17,685/-. Thus, a sum of Rs.10,41,124/- was therefore available with her to meet out the household expenditure of her family consisting of three members in the financial year 2022-2024 (2022-23 & 2023-24).

It is pertinent to mention here that her husband is posted as Presiding Officer M.A.C.T. in the pay scale (Revised) 2,19,090/-, in the above period (as mentioned by the officer).

In this connection, it is submitted that the officer has already submitted her movable and immovable property statements for the financial year 2020-2022 (2020-21 & 2021-22) online against Case Id : P0002012023 and the same has been processed before Hon'ble Mr. Justice Rajeev Misra, Administrative Judge, Jaunpur Judgeship for His Lordship's kind perusal and orders.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit her property statement for the financial year 2022-2024 (2022-23 & 2023-24) in its next financial year i.e., 2024-25 upto March 2025. She has submitted movable and immovable property statements of the financial year 2022-2024 (2022-23 & 2023-24) vide online dated 05.7.2024. As such, there is no delay in submitting the same.

May, therefore, if approved, property statements for the financial year 2022-2024 (2022-23 & 2023-24) of Smt. Reeta Kaushik, Principal Judge, Family Court, Jaunpur, be laid before Hon'ble Mr. Justice Rajeev Misra, Administrative Judge, Jaunpur Judgeship for His Lordship's kind perusal and orders?
