May kindly see the property statement received online from Sri Arun Kumar Pathak, Presiding Officer, Commercial Court, Lucknow regarding submission of statement of movable and immovable properties acquired/held by him or any member of his family of the financial years 2022-24 (2022-23 & 2023-24) in the prescribed proforma respectively to this Hon'ble Court for kind perusal and information as required by the Hon'ble Court.

In this connection, it is submitted that as per the statement of movable and immovable properties for the financial years 2022-24 (2022-23 & 2023-24) of the officer concerned, details of income, deduction, savings investment and expenditure made by him are given below:

(1) In the financial years 2022-24 (2022-23 & 2023-24), Gross income from salary & arrears is Rs.1,29,54,215/- and total deductions/savings/repayment/ investment against GPF, GIS, Income Tax, PPF, RD, SBI policy, Home loan and the balance of his savings bank account is also enhanced by Rs.36,70,092/- in this financial year from previous year's balance, total of which is Rs.86,74,335/-. Thus, a sum of Rs.42,79,880/- was therefore available with him to meet out the household expenditure of his family consisting of four members in both of the financial years.

It is pertinent to mention here that his wife's annual income is Rs.4,57,380/- & Rs.6,05,403/- from teaching & boutique work for the financial year 2022-23 & 2023-24 respectively and his daughter's annual income from job is Rs.8,50,000/- & 9,01,855/- for this period, as mentioned by the officer.

In this connection, it is submitted that the Officer has submitted his property statements upto the financial years 2020-22 and the same has also been processed online against Case Id : P00060632022 before Hon'ble Mrs. Justice Sangeeta Chandra, Administrative Judge, Lucknow Judgeship for Her Lordship's kind perusal and orders.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit his property statement for the financial years 2022-24 (2022-23 & 2023-24) in its next financial year i.e., 2024-25 upto March 2025. He has submitted his movable and immovable property statements for the financial years 2022-24 (2022-23 & 2023-24) vide online dated 06.08.2024. As such, there is no delay in submitting the same.

May, therefore, if approved, property statements for the financial years 2022-24 (2022-23 & 2023-24) of Sri Arun Kumar Pathak, Presiding Officer, Commercial Court, Lucknow be laid before Hon'ble Mrs. Justice Sangeeta Chandra, Administrative Judge, Lucknow Judgeship for Her Lordship's kind perusal and orders?
