May kindly see the property statement online received from Smt. Shilpe Rani, Addl. Civil Judge (Sr.Div.)/ACJM, Bareilly regarding submission of statement of movable and immovable properties acquired/held by her or any member of her family of the financial years 2018-20 (2018-19 and 2019-20) in the prescribed proforma respectively to this Hon'ble Court for kind perusal and information as required by the Hon'ble Court.

In this connection, it is submitted that as per the statement of movable and immovable properties for the financial years 2018-20 (2018-19 and 2019-20) of the officer concerned, details of income, deduction, savings investment and expenditure made by her are given below:

In the financial years 2018-20 (2018-19 and 2019-20), her gross income from salary is Rs.29,21,939/- and total deductions/Savings/investments NPS, GIS, Income Tax, PPF, RD, Sukanya Samriddhi Yojna, Repayment of Car loan and Insurances are Rs.14,72,543/-. The balance of Rs.43,469/- has increased from her saving bank A/c's against the balance of the previous year. Thus a sum of Rs.14,49,396/- was therefore available with her to meet out the household expenditure of her family consisting three members in the financial years 2018-20 (2018-19 and 2019-20).

It is to pertinent mention here that officer's husband [Regional Manager, Ruosh Company, Delhi] having annual income was Rs.9,99,635/- for the financial years 2018-19 and 2019-20 respectively.

In this connection, it is submitted that the Officer has already submitted her property statement held at the time of Joining in to U.P. Judicial Service as well as for the financial years 2014-16 & 2016-18 in offline. Which had already been seen by Hon'ble Mr. Justice Pankaj Naqvi, the then Administrative Judge, Rampur Judgship in the Misc. file of the officer.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit her property statement for the financial years 2018-20 (2018-19 and 2019-20) in its next financial year i.e., 2020-21 upto March 2021. She had submitted movable and immovable property statements for the financial years 2018-20 (2018-19 and 2019-20) vide online dated 23.07.2024 on eServicesJo portal. As such, there is delay in submitting the same. In this regard, officer's verbatim: ".....the undersigned hereby most humbly tenders as unconditional apology for delay in submitting the above mentioned statements in due time and undertake that such delay will not occur in future."

May, therefore, if approved, property statements for the financial years 2018-20 (2018-19 and 2019-20) of Smt. Shilpe Rani, Addl. Civil Judge (Sr.Div.)/ACJM, Bareilly be laid before Hon'ble Mr. Justice Vivek Chaudhary, Administrative Judge, Bareilly Judgship for His Lordship's kind perusal and orders?
