May kindly see the property statement online received from Smt. Shilpe Rani, Addl. Civil Judge (Sr.Div.)/ACJM, Bareilly regarding submission of statement of movable and immovable properties acquired/held by her or any member of her family of the financial years 2020-22 (2020-21 and 2021-22) in the prescribed proforma respectively to this Hon'ble Court for kind perusal and information as required by the Hon'ble Court.

In this connection, it is submitted that as per the statement of movable and immovable properties for the financial years 2020-22 (2020-21 and 2021-22) of the officer concerned, details of income, deduction, savings investment and expenditure made by her are given below:

**In the financial years 2020-22 (2020-21 and 2021-22)**, her gross income from salary is Rs.30,54,728/- and total deductions/Savings/investments NPS, GIS, Income Tax, PPF, NSC, RD, Sukanya Samridhhi Yojna, Repayment of Car loan, Mutual funds and Insurances are Rs.24,50,728/-. The balance of Rs.4,57,365/- has increased from her saving bank A/c's against the balance of the previous year. Thus a sum of Rs.6,04,000/- was therefore available with her to meet out the household expenditure of her family consisting three members in the financial years 2020-22 (2020-21 and 2021-22).

It is pertinent to mention here that officer's husband [Regional Manager, North (Delhi)] having annual income was Rs.11,04,000/- for the financial years 2020-21.

In this connection, it is submitted that the Officer has already submitted her property statement for the financial years 2018-20 (2018-19 and 2019-20) online against case id: ( P00006852024) and same has been processed before Hon'ble Mr. Justice Vivek Chaudhary, Administrative Judge, Bareilly Judgeship for His Lordship's kind perusal and orders.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit her property statement for the financial years 2020-22 (2020-21 and 2021-22) in its next financial year i.e., 2022-23 upto March 2023. She had submitted movable and immovable property statements for the financial years 2020-22 (2020-21 and 2021-22) vide online dated 23.07.2024 on eServicesJo portal. As such, there is delay in submitting the same. In this regard, officer's verbatim: ".....the undersigned hereby most humbly tenders as unconditional apology for delay in submitting the above mentioned statements in due time and undertake that such delay will not occur in future." (Delay reason attached).

May, therefore, if approved, property statements for the financial years 2020-22 (2020-21 and 2021-22) of Smt. Shilpe Rani, Addl.
