May kindly see the property statement online received from Smt. Shilpe Rani, Addl. Civil Judge (Sr.Div.)/ACJM, Bareilly regarding submission of statement of movable and immovable properties acquired/held by her or any member of her family of the financial years 2022-24 (2022-23 and 2023-24) in the prescribed proforma respectively to this Hon'ble Court for kind perusal and information as required by the Hon'ble Court.

In this connection, it is submitted that as per the statement of movable and immovable properties for the financial years 2022-24 (2022-23 and 2023-24) of the officer concerned, details of income, deduction, savings investment and expenditure made by her are given below:

In the financial years 2022-24 (2022-23 and 2023-24), her gross income from salary is Rs.75,83,669/- and total deductions/Savings/investments NPS, GIS, Income Tax, PPF, NSC, RD, Sukanya Samriddhi Yojna, Repayment of Car loan, Mutual funds and Insurances are Rs.67,06,069/-. The balance of Rs.36,11,975/- has increased from her saving bank A/c's against the balance of the previous year. Thus a sum of Rs.8,77,600/- was therefore available with her to meet out the household expenditure of her family consisting four members in the financial years 2022-24 (2022-23 and 2023-24).

It is to pertinent mention here that officer's husband [Retail Operation Manager, (Delhi)] having annual income was Rs.12,60,000/- for the financial years 2020-21 and Rs.13,80,000/- for the financial year 2021-22 respectively.

In this connection, it is submitted that the Officer has already submitted her property statement for the financial years 2020-22 (2020-21 and 2021-22) online against case id: (P00006862024) and same has been processed before Hon'ble Mr. Justice Vivek Chaudhary, Administrative Judge, Bareilly Judgeship for His Lordship's kind perusal and orders.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit her property statement for the financial years 2022-24 (2022-23 and 2023-24) in its next financial year i.e., 2024-25 upto March 2025. She had submitted movable and immovable property statements for the financial years 2022-24 (2022-23 and 2023-24) vide online dated 23.07.2024 on eServicesJo portal. As such, there is no delay in submitting the same.

May, therefore, if approved, property statements for the financial years 2022-24 (2022-23 and 2023-24) of Smt. Shilpe Rani, Addl. Civil Judge (Sr.Div.)/ACJM, Bareilly be laid before Hon'ble Mr. Justice Vivek Chaudhary, Administrative Judge, Bareilly Judgeship for His Lordship's kind perusal and orders?
