May kindly see the property statement online received from Sri Piyush Siddhartha, Additional District & Sessions Judge, Firozabad regarding submission of statement for movable and immovable properties acquired/held by him or any member of his family of the financial years 2021-23 (2021-22 & 2022-23) in the prescribed proforma respectively to this Hon'ble Court for kind perusal and information as required by the Hon'ble Court.

In this connection, it is submitted that as per the statement of movable and immovable properties for the financial years 2021-23 (2021-22 & 2022-23) of the officer concerned, details of income, deduction, savings investment and expenditure made by him are given below:

In the financial years 2021-23 (2021-22 & 2022-23), his gross income from salary is Rs.33,31,483/- and total deductions/Savings/investments against, NPS, GIS, Income Tax, PPF, NSC, Insurances and Payment house purchase are Rs.49,69,375/-. The balance of Rs.27,80,158/- has decreased from his saving bank A/c's against the balance of the previous year. Thus a sum of Rs.11,42,266/- (from saving bank account withdrawal) was therefore available with him to meet out the household expenditure of his family consisting four members in the financial years 2021-23 (2021-22 & 2022-23).

In this connection, it is submitted that the Officer has already submitted his property statement for the financial years 2019-21 (2019-20 & 2020-21) online against case id-P00049452021 (old case id:7107), which had already been seen by Hon'ble Mr. Justice Attau Rahman Masoodi, the then Administrative Judge, Bareilly Judgeship.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit his property statement for the financial years 2021-23 (2021-22 & 2022-23) in its next financial year i.e., 2023-24 upto March 2024. He has submitted movable and immovable property statements for the financial years 2021-23 (2021-22 & 2022-23) vide online dated 24.07.2024. As such, there is delay in submitting the same. In this regard officer's verbatim: "Sir, I had to face a surgery (cholecystectomy) in December 2023 and later on due to complication, ERCP of Common Bile Duct was done in January 2014. Due to these health issues, I could not collect the details. The delay caused in submitting the statements may kindly be condoned. I shall highly be obliged."

May, therefore, if approved, property statements for the financial years 2021-23 (2021-22 & 2022-23) of Sri Piyush Siddhartha, Additional District & Sessions Judge, Firozabad be laid before Hon'ble Dr. Justice Gautam Chowdhary, Administrative Judge, Firozabad Judgeship for His Lordship's kind perusal and orders?
