It is further submitted that as per policy/Court's Circular Letter, the officer has to submit his property statement for the financial year 2022-2024 (2022-23 & 2023-24) in its next financial year i.e., 2024-25 upto March 2025. He has submitted movable and immovable property statements of the financial year 2022-2024 (2022-23 & 2023-24) vide online dated 26.07.2024. As such, there is no delay in submitting the same.
