In this connection, it is submitted that as per the statement of movable and immovable properties for the financial years 2022-24 (2022-23 & 2023-24) of the officer concerned, details of income, deduction, savings investment and expenditure made by him are given below:

(1) In the financial years 2022-24 (2022-23 & 2023-24), Gross income is Rs.1,06,17,802/- from salary and arrears and total deductions/savings/investment against NPS, GIS, Income Tax, Home loan and the balance of his savings bank account is also enhanced by Rs.28,80,028/- in this financial year from previous year's balance, total of which is Rs.82,44,682/-. Thus, a sum of Rs.23,73,120/- was therefore available with him to meet out the household expenditure of his family consisting of five members in both of the financial years. It is pertinent to mention here that his father's annual income from farming is Rs.2,50,000/- & 2,50,000/- (approx), in the financial year 2022-23 & 2023-24 respectively.

In this connection, it is submitted that the Officer has submitted his property statement upto the financial years 2020-22 and the same has also been processed online against Case Id: P00064792022 before Hon'ble Mr. Justice Arvind Singh Sangwan, Administrative Judge, Rae Bareli Judgeship for His Lordship's kind perusal and orders.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit his property statement for the financial years 2022-24 (2022-23 & 2023-24) in its next financial year i.e., 2024-25 upto March 2025. He has submitted his movable and immovable property statement for the financial years 2022-24 (2022-23 & 2023-24) vide online dated 21.08.2024. As such, there is no delay in submitting the same.

May, therefore, if approved, property statements for the financial years 2022-24 (2022-23 & 2023-24) of Sri Ram Net, Special Judge (E.C. Act), Rae Bareli be laid before Hon'ble Mr. Justice Arvind Singh Sangwan, Administrative Judge, Rae Bareli Judgeship for His Lordship's kind perusal and orders?
