May kindly see the property statement received online from Sri Ram Raj-II, Addl. District & Sessions Judge, Mathura regarding submission of statement of movable and immovable properties acquired/held by him or any member of his family of the financial year 2008-2010 (2008-09 & 2009-10) in the prescribed proforma respectively to this Hon'ble Court for kind perusal and information as required by the Hon'ble Court.

In this connection, it is submitted that as per the statement of movable and immovable properties for the financial year 2008-2010 (2008-09 & 2009-10) of the officer concerned, details of income, deduction, savings investment and expenditure made by him are given below:

In the financial year 2008-2010 (2008-09 & 2009-10), the Gross income from salary is Rs.5,82,535/- and total deductions/savings/investment against GIS, GPF, PPF, Loan repayments and Income Tax is Rs.2,25,296/-. Thus, a sum of Rs.3,57,239/- was therefore available with him to meet out the household expenditure of his family consisting three members of the financial year 2008-2010 (2008-09 & 2009-10) and the balance of his savings bank account(s) is also decreased by Rs.1,364/- in this financial year from previous year's balance.

In this connection, it is submitted that the Officer has already submitted his property statement for the financial year 2006-2008 (2006-07 & 2007-08) online against Case Id: P00007692024 and the same has been processed before Hon'ble Mr. Justice Sanjay Kumar Singh, Administrative Judge, Mathura Judgeship for His Lordship's kind perusal and orders.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit his property statement for the financial year 2008-2010 (2008-09 & 2009-10) in its next financial year i.e., 2010-11 upto March 2011. In this regard, it is submitted that earlier, the officer had submitted his property statements at the time of joining Judicial Service and for financial year 2006-07, 2007-08, 2008-09 & 2009-10 in offline mode vide Endorsement No. 971/971-XV-1-II dated 09.09.2011. As such, there is delay in submitting the aforesaid property statements from the part of the officer for which, he has stated in the remark column of movable proforma, that:
