May kindly see the property statements submitted online received from Sri Ram Manohar Narayan Mishra, Director, Institute of Judicial Training & Research, Lucknow regarding submission of statement of movable and immovable properties acquired/held by him or any member of his family for the financial years 2014-15 & 2015-16 in the prescribed proforma respectively to this Court for kind perusal and information as required by the Court.

In this connection, it is submitted that as per statement of movable and immovable properties for the financial years 2014-15 & 2015-16 of the officer concerned, details of income, deduction, savings investment and expenditure made by him are given below.

(1) In the financial years 2014-15 & 2015-16, Total income is Rs.42,86,345/- (income from salary is Rs.37,50,596/-, Agricultural income of Rs.1,18,000/-, SB A/c interests of Rs.9,000/-, surrender value of LIC policy of Rs.64,005/-, maturity of LIC policy of Rs.2,00,600/- and matured amount of RD of Rs.1,44,144/-) and total deductions/ repayment/ savings/ investment (for both the financial years) against GPF, GIS, Income Tax, Insurance policies, PPF a/c, RD and the balance of his savings bank account(s) is enhanced for Rs.2,01,281/- this financial year from previous year's balance, total of which is Rs.13,48,431/-. Thus, a sum of Rs.29,37,914/- was therefore available with him to meet out the household expenditure of his family consisting five members in both the financial years.

It is pertinent to mention here that his elder son is working as Sub-lieutenant, Indian Navy having monthly income of Rs.56,000/- approx.

In this connection, it is submitted that the officer has already submitted his property statement upto the financial year 2013-14 which had already been seen by Hon'ble Mr. Justice Vikram Nath, the then Administrative Judge, Lucknow in the misc. file of the officer.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit his property statement for the financial years 2014-15 & 2015-16 in its next financial year i.e., 2016-17 upto March 2017. He has submitted movable and immovable property statements for the financial years 2014-15 & 2015-16 vide online dated 28.08.2020. As such, there is delay in submitting the same from the part of the officer for which he has stated that "delay occasioned in delayed submission of property statement is due to factor of various inter district transfers, rush of judicial and administrative work in different capacities and also on account of time taken in removal of objections in submission of property statement. The delay is deeply regretted and apologized with utmost humility" mentioned in his reply dated 02.12.2020.

May, therefore, if approved, property statements for the financial years 2014-15 & 2015-16 of Sri Ram Manohar Narayan Mishra, Director, Institute of Judicial Training & Research, Lucknow be laid before Hon'ble Mr. Justice Surya Prakash Kesarwani, Administrative Judge, Lucknow Judgeship for His Lordship's kind perusal and orders?
