

## **Registrar(J)(Budget)**

May kindly see the property statement received online from Sri Ram Raj-II, Addl. District & Sessions Judge, Mathura regarding submission of statement of movable and immovable properties acquired/held by him or any member of his family of the financial year 2016-2018 (2016-17 & 2017-18) in the prescribed proforma respectively to this Hon'ble Court for kind perusal and information as required by the Hon'ble Court.

In this connection, it is submitted that as per the statement of movable and immovable properties for the financial year 2016-2018 (2016-17 & 2017-18) of the officer concerned, details of income, deduction, savings investment and expenditure made by him are given below:

**In the financial year 2016-2018 (2016-17 & 2017-18)**, the Gross income is Rs.28,87,502/- (Rs.26,15,332/- from salary & Rs.2,72,170/- from Maturity of NSC) and total deductions/savings/investment against GIS, NPS, PPF, Insurances, Loan repayments and Income Tax is Rs.9,66,394/-, and the balance of his savings bank account(s) is also increased by Rs.35,723/- in this financial year from previous year's balance, total of which is Rs.10,02,117/-. Thus, a sum of Rs.18,85,385/- was therefore available with him to meet out the household expenditure of his family consisting four members of the financial year 2016-2018 (2016-17 & 2017-18).

In this connection, it is submitted that the Officer has already submitted his property statement for the financial year 2014-2016 (2014-15 & 2015-16) online against Case Id : P00007952024 and the same has been processed before Hon'ble Mr. Justice Sanjay Kumar Singh, Administrative Judge, Mathura Judgeship for His Lordship's kind perusal and orders.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit his property statement for the financial year 2016-2018 (2016-17 & 2017-18) in its next financial year i.e., 2018-19 upto March 2019. In this regard, it is submitted that earlier, the officer had submitted his property statements for financial year 2010-11 to 2017-18 in offline mode vide Endorsement No. 1663/Admin XV dated 03.08.2019 (placed in the misc. file of the officer). As such, there is delay in submitting the aforesaid property statements from the part of the officer for which, he has stated in his letter dated 03.08.2019 that due to busyness of judicial work and being busy in transfer four times during this period, he could not prepare the property statements, due to which the property statement for stipulated years got delayed for which he seeks apology and assures that he will timely submit the next property property statement which is due in 2021.

May, therefore, if approved, property statements for the financial year 2016-2018 (2016-17 & 2017-18) of Sri Ram Raj-II, Addl. District & Sessions Judge, Mathura, be laid before Hon'ble Mr. Justice Sanjay Kumar Singh, Administrative Judge, Mathura Judgeship for His Lordship's kind perusal and orders?
