May kindly see the property statement received online from Sri Shobit Bansal, Additional Civil Judge (Sr.Div.)/ACJM., Rampur regarding submission of statement of movable and immovable properties acquired/held by him or any member of his family of the financial years 2022-24 (2022-23 & 2023-24) in the prescribed proforma respectively to this Hon'ble Court for kind perusal and information as required by the Hon'ble Court.

In this connection, it is submitted that as per the statement of movable and immovable properties for the financial years 2022-24 (2022-23 & 2023-24) of the officer concerned, details of income, deduction, savings investment and expenditure made by him are given below:

(1) In the financial years 2022-24 (2022-23 & 2023-24), Gross income is Rs.64,99,556/- and total deductions/savings/investment against NPS, GIS, Income Tax, LIC, PPF, Health Insurance, Term plan, mutual funds, FD and the balance of his savings bank account is also enhanced by Rs.21,82,538/- in this financial year from previous year's balance, total of which is Rs.57,13,292/-. Thus, a sum of Rs.7,86,264/- was therefore available with him to meet out the household expenditure of his family consisting three members in both of the financial years. It is pertinent to mention here that Officer's wife is working as lawyer whose annual income is Rs.6,00,000/-, as mentioned by the Officer.

In this connection, it is submitted that the Officer has submitted his property statement upto the financial years 2020-22 and the same has also been processed online against Case Id : P00065602022 before Hon'ble Mr. Justice Subhash Chandra Sharma, Administrative Judge, Rampur Judgeship for His Lordship's kind perusal and orders.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit his property statement for the financial years 2022-24 (2022-23 & 2023-24) in its next financial year i.e., 2024-25 upto March 2025. He has submitted his movable and immovable property statement for the financial years 2022-24 (2022-23 & 2023-24) vide online dated 07.08.2024. As such, there is no delay in submitting the same.

May, therefore, if approved, property statements for the financial years 2022-24 (2022-23 & 2023-24) of Sri Shobit Bansal, Additional Civil Judge (Sr.Div.)/ACJM., Rampur be laid before Hon'ble Mr. Justice Subhash Chandra Sharma, Administrative Judge, Rampur Judgeship for His Lordship's kind perusal and orders?
