In this connection, it is submitted that as per statements of movable and immovable properties for the financial years 2022-24 (2022-23 and 2023-24) of the Officer concerned, details of income, deductions, savings, investment and expenditure made by him are shown in subsequent paragraph.

In the financial years 2022-24 (2022-23 and 2023-24), his gross income from salary, arrears of SNJPC and other sources is Rs.1,26,93,465/- (Rs.1,26,33,473/- from salary & arrears, Rs. 15,996/- from SBI interest and Rs. 43,454/- from maturity of REC L&T bond) and total of deductions/Savings /investments against NPS/GPF/CPF, GIS, income tax, PPF, car and home loan- repayment, Sukanya Samiridhi Yojna, Bajaj Allianz pension scheme, Insurances, mutual fund and increase in his savings bank accounts from previous year's balance, comes to Rs. 76,77,233/-. The movable and immovable property statement for the financial years 2022-24 (2022-23 and 2023-24) have been submitted by the officer vide his online application dated 14.08.2024 which is due to be submitted upto the end of the financial year 2024-25 i.e upto 31.03.2025. As such, there is no delay in submitting the property statements from the part of the officer.
