He has firstly submitted movable and immovable property statements of the financial year 2020-2022 (2020-21 & 2021-22) vide online dated 28.08.2024. As such, there is delay in submitting the aforesaid property statements from the part of the officer for which, he has stated in the remark column of movable proforma, that:
