May kindly see the property statement received online from Dr. Avanish Kumar-II, Spl. Judge (U.P. Dacoity.A.A.), Jalaun at Orai regarding submission of statement of movable and immovable properties acquired/held by him or any member of his family of the financial year 2020-2022 (2020-21 & 2021-22) in the prescribed proforma respectively to this Hon'ble Court for kind perusal and information as required by the Hon'ble Court.

In this connection, it is submitted that as per the statement of movable and immovable properties for the financial year 2020-2022 (2020-21 & 2021-22) of the officer concerned, details of income, deduction, savings investment and expenditure made by him are given below:

In the financial year 2020-2022 (2020-21 & 2021-22), the Gross income from Salary is Rs.42,52,979/- and total deductions/savings/investment against GIS, NPS, SIP, Insurances, HDFC deposit and Income Tax is Rs.15,96,208/- and the balance of his savings bank account(s) is also increased by Rs.3,32,339/- in this financial year from previous year's balance, total of which is Rs.19,28,547/-. Thus, a sum of Rs.23,24,432/- was therefore available with him to meet out the household expenditure of his family consisting four members of the financial year 2020-2022 (2020-21 & 2021-22).

In this connection, it is submitted that the Officer has already submitted his property statement for the financial year 2018-2020 (2018-19 & 2019-20) online against Case Id : P00013362021 (Old Case Id : 3443) and the same has been processed before Hon'ble Mr. Justice Sameer Jain, Administrative Judge, Jalaun at Orai Judgeship for His Lordship's kind perusal and orders.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit his property statement for the financial year 2020-2022 (2020-21 & 2021-22) in its next financial year i.e., 2022-23 upto March 2023. He has firstly submitted movable and immovable property statements of the financial year 2020-2022 (2020-21 & 2021-22) vide online dated 27.08.2024. As such, there is delay in submitting the same from the part of the officer for which the officer has stated in his online reply dated 27.08.2024, that:

"It is humbly submitted that my property statement for the years 2020-22 was due till March 2023, but since this statement was for the Covid period, so I could not collect all the relevant informations and documents within time and then due to very busy schedule in the court and my transfer from Lucknow to Jalaun at Orai in April 2023, I could not submit it in time. I apologize for late submission of my property statement."

May, therefore, if approved, property statements for the financial year 2020-2022 (2020-21 & 2021-22) of Dr. Avanish Kumar-II, Spl. Judge (U.P. Dacoity.A.A.), Jalaun at Orai, be laid before Hon'ble Mr. Justice Sameer Jain, Administrative Judge, Jalaun at Orai Judgeship for His Lordship's kind perusal and orders?
