In the financial year 2022-2024 (2022-23 & 2023-24), the Gross income from salary is Rs.1,05,14,868/- and total deductions/savings/investment against NPS, GIS, Insurances, SIP and Income Tax is Rs.32,09,966/- and the balance of his savings bank account(s) is also increased by Rs.35,63,765/- in this financial year from previous year's balance, total of which is Rs.67,73,731/-. Thus, a sum of Rs.37,41,137/- was therefore available with him to meet out the household expenditure of his family consisting four members of the financial year 2022-2024 (2022-23 & 2023-24).

In this connection, it is submitted that the Officer has already submitted his property statement for the financial year 2020-2022 (2020-21 & 2021-22) online against Case Id : P00008532024 and the same has been processed before Hon'ble Mr. Justice Sameer Jain, Administrative Judge, Jalaun at Orai Judgeship for His Lordship's kind perusal and orders.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit his property statement for the financial year 2022-2024 (2022-23 & 2023-24) in its next financial year i.e., 2024-25 upto March 2025. He has submitted movable and immovable property statements of the financial year 2022-2024 (2022-23 & 2023-24) vide online dated 27.08.2024. As such, there is no delay in submitting the same.
