May kindly see the property statement received online from Sri Kuldeep Singh-III, A.D.J. (FTC), Mainpuri, regarding submission of statement of movable and immovable properties acquired/held by him or any member of his family of the financial year 2015-2017 (2015-16 & 2016-17) in the prescribed proforma respectively to this Hon'ble Court for kind perusal and information as required by the Hon'ble Court.

In this connection, it is submitted that as per the statement of movable and immovable properties for the financial year 2015-2017 (2015-16 & 2016-17) of the officer concerned, details of income, deduction, savings investment and expenditure made by him are given below:

In the financial year 2015-2017 (2015-16 & 2016-17), the Gross income from salary is Rs.19,17,781/- and total deductions/savings/investment against NPS, GIS, PPF, Insurances and Income Tax is Rs.4,03,981/-. Thus, a sum of Rs.15,13,800/- was therefore available with him to meet out the household expenditure of his family consisting three members for the financial year 2015-2017 (2015-16 & 2016-17) and the balance of his savings bank account(s) is also decreased by Rs.33,592/- in this financial year from previous year's balance.

In this connection, it is submitted that the Officer has already submitted his property statement for financial year 2013-2015 (2013-14 & 2014-15) offline and the same has been seen by Hon'ble Mr. Justice Harsh Kumar, the then Administrative Judge, Shahjahanpur Judgeship in the misc. file of officer.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit his property statement for the financial year 2015-2017 (2015-16 & 2016-17) in its next financial year i.e., 2017-18 upto March 2018. He has firstly submitted movable and immovable property statements of the financial year 2015-2017 (2015-16 & 2016-17) in offline mode vide Endorsement no. 996/I dated 13.09.2018. As such, there is delay in submitting the same for which the officer has stated in his application as attachment dated 28.08.2024, that:

"As per two year block policy of the Hon'ble Court for the financial years 2015-17, 2017-19, 2019-21, 2021-23 and 2023-25, the officer has to submit his property statements for the financial years 2015-16, 2016-17 and 2017-18 in its next financial year i.e., 2018-19 upto March 2019. He has firstly submitted movable and immovable property statements of the financial years 2015-16, 2016-17 and 2017-18 in offline mode vide Endorsement no. 996/I dated 13.09.2018. As such, there is delay in submitting the same for which the officer has stated in his application as attachment dated 28.08.2024, that:
