May kindly see the property statement received online from Sri Kuldeep Singh-III, A.D.J. (FTC), Mainpuri, regarding submission of statement of movable and immovable properties acquired/held by him or any member of his family of the financial year 2019-2021 (2019-20 & 2020-21) in the prescribed proforma respectively to this Hon'ble Court for kind perusal and information as required by the Hon'ble Court.

In this connection, it is submitted that as per the statement of movable and immovable properties for the financial year 2019-2021 (2019-20 & 2020-21) of the officer concerned, details of income, deduction, savings investment and expenditure made by him are given below:

In the financial year 2019-2021 (2019-20 & 2020-21), the Gross income from salary is Rs.33,62,354/- and total deductions/savings/investment against NPS, GIS, PPF, Insurances, and Income Tax is Rs.10,30,149/- and the balance of his savings bank account(s) is also increased by Rs.99,896/- in this financial year from previous year's balance, total of which is Rs.11,30,045/-. Thus, a sum of Rs.22,32,309/- was therefore available with him to meet out the household expenditure of his family consisting three members of the financial year 2019-2021 (2019-20 & 2020-21).

In this connection, it is submitted that the Officer has already submitted his property statement for the financial year 2017-2019 (2017-18 & 2018-19) online against Case Id : P00008862024 and the same has been processed before Hon'ble Mr. Justice Donadi Ramesh, Administrative Judge, Mainpuri Judgeship for His Lordship's kind perusal and orders.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit his property statement for the financial year 2019-2021 (2019-20 & 2020-21) in its next financial year i.e., 2021-22 upto March 2022. He has submitted movable and immovable property statements of the financial year 2019-2021 (2019-20 & 2020-21) vide online dated 29.08.2024. As such, there is delay in submitting the same for which the officer has stated in his application as attachment dated 28.08.2024, that:

"As per two year block policy 2015-17, 2017-19, 2019-21 & 2021-23 the officer has submitted the property statements for the financial year 2015-16, 2016-17 & 2017-18 vide offline dated 13.09.2018 and for financial year 2018-2020 online against Case Id: P00027652021 on dated 21.12.2021. After perusal of statements, As per two year block policy, objections were raised against Case Id: P00027652021, asking officer to submit the property statement for correct block years i.e. for financial year 2015-2017, 2017-2019 & 2019-2021, instead of submitting for financial year 2018-2020. In reply to the objections, officer has submitted the property statement for financial year 2015-2017, 2017-2019 & 2019-2021 dated 29.08.2024 through online against Case Id: P00008842024, P00008862024 & P00008872024 respectively. As such there is delay in submitting the property statement for financial year 2015-2017, 2017-2019 & 2019-2021 for which the officer has given reason for delay.

In this connection, it is submitted that earlier the officer has submitted the property statements for financial year 2015-16, 2016-17 & 2017-18 vide offline dated 13.09.2018 and for financial year 2018-2020 online against Case Id: P00027652021 on dated 21.12.2021. After perusal of statements, As per two year block policy, objections were raised against Case Id: P00027652021, asking officer to submit the property statement for correct block years i.e. for financial year 2015-2017, 2017-2019 & 2019-2021, instead of submitting for financial year 2018-2020. In reply to the objections, officer has submitted the property statement for financial year 2015-2017, 2017-2019 & 2019-2021 dated 29.08.2024 through online against Case Id: P00008842024, P00008862024 & P00008872024 respectively. As such there is delay in submitting the property statement for financial year 2015-2017, 2017-2019 & 2019-2021 for which the officer has given reason for delay.

May, therefore, if approved, property statements for the financial year 2019-2021 (2019-20 & 2020-21) of Sri Kuldeep Singh-III, A.D.J. (FTC), Mainpuri, be laid before Hon'ble Mr. Justice Donadi Ramesh, Administrative Judge, Mainpuri Judgeship for His Lordship's kind perusal and orders?
