May kindly see the property statement received online from Sushri Shirin Zaidi, Special Judge (SC/ST, Pev.of Atroci Act), Kaushambi regarding submission of statement of movable and immovable properties acquired/held by her or any member of her family for the financial year 2021-2023 (2021-22 & 2022-23) in the prescribed proforma respectively to this Court for kind perusal and information as required by the Court.

In this connection, it is submitted that as per statement of movable and immovable properties for the financial year 2021-2023 (2021-22 & 2022-23) of the officer concerned, details of income, deduction, savings investment and expenditure made by her are given below:

In the financial year 2021-2023 (2021-22 & 2022-23), the Gross income from salary is Rs.45,13,185/- and total deductions/ repayment/ savings/ investment against GIS, NPS, Income Tax, PPF and Mutual Funds are Rs.14,62,914/-, and the balance of her savings bank account is also increased by Rs.35,373/- in this financial year from previous year's balance, total of which is Rs.14,98,287/-. Thus, a sum of Rs.30,14,898/- was therefore available with herself to meet out the household expenditure in the financial year 2021-2023 (2021-22 & 2022-23).

In this connection, it is submitted that the officer has already submitted her movable and immovable property statements for the financial year 2019-2021 (2019-20 & 2020-21) online against Case Id : P00004212023 and the same has been processed before Hon'ble Mr. Justice Surendra Singh-I, Administrative Judge, Kaushambi Judgeship for His Lordship's kind perusal and orders.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit her property statement for the financial year 2021-2023 (2021-22 & 2022-23) in its next financial year i.e., 2023-24 upto March 2024. She has submitted movable and immovable property statements of the financial year 2021-2023 (2021-22 & 2022-23) vide online dated 06.09.2024. As such, there is delay in submitting the same from the part of the officer for which she has stated in her online reply dated 03.09.2024, that *"I tender my apologies for not submitting the property statement on time as I was transferred in 2023 and due to other family emergencies also, I inadvertently missed submitting the property statement in time."*

May, therefore, if approved, property statements for the financial year 2021-2023 (2021-22 & 2022-23) of Sushri Shirin Zaidi, Special Judge (SC/ST, Pev.of Atroci Act), Kaushambi, be laid before Hon'ble Mr. Justice Surendra Singh-I, Administrative Judge, Kaushambi Judgeship for His Lordship's kind perusal and orders?
