

## **Registrar(J)(Budget)**

May kindly see the property statement received online from Sri Ashish Kumar Chaurasia, Addl. District & Sessions Judge, Lucknow, regarding submission of statement of movable and immovable properties acquired/held by him or any member of his family of the financial year 2022-2024 (2022-23 & 2023-24) in the prescribed proforma respectively to this Hon'ble Court for kind perusal and information as required by the Hon'ble Court.

In this connection, it is submitted that as per the statement of movable and immovable properties for the financial year 2022-2024 (2022-23 & 2023-24) of the officer concerned, details of income, deduction, savings investment and expenditure made by him are given below:

**In the financial year 2022-2024 (2022-23 & 2023-24)**, the Gross income is Rs.90,12,259/- and total deductions/savings/investment against GIS, NPS, Insurances, PPF, Mutual Funds, loan repayments and Income Tax is Rs.34,93,507/- and the balance of his savings bank account(s) is also increased by Rs.20,54,819/- in this financial year from previous year's balance, total of which is Rs.55,48,326/-. Thus, a sum of Rs.34,63,933/- was therefore available with him to meet out the household expenditure of his family consisting four members of the financial year 2022-2024 (2022-23 & 2023-24).

It is pertinent to mention here that his wife have annual income of Rs.3,95,000/- & Rs.4,82,970/- from Teaching/Tution in the financial year 2022-23 & 2023-24 respectively.

In this connection, it is submitted that the Officer has already submitted his property statement for the financial year 2020-2022 (2020-21 & 2021-22) online against Case Id : P00001492024 and the same has been seen by Hon'ble Mr. Justice Kshitij Shailendra, the then Administrative Judge, Lucknow Judgeship with remark ".....,The officer should keep on updating records so that, in future, delay does not occur in submission of property statements."

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit his property statement for the financial year 2022-2024 (2022-23 & 2023-24) in its next financial year i.e., 2024-25 upto March 2025. He has submitted movable and immovable property statements of the financial year 2022-2024 (2022-23 & 2023-24) vide online dated 09.09.2024. As such, there is no delay in submitting the same.

May, therefore, if approved, property statements for the financial year 2022-2024 (2022-23 & 2023-24) of Sri Ashish Kumar Chaurasia, Addl. District & Sessions Judge, Lucknow, be laid before Hon'ble Mrs. Justice Sangeeta Chandra, Administrative Judge, Lucknow Judgeship for Her Lordship's kind perusal and orders?
