May kindly see the online property statements received from Sri Radhey Mohan Srivastava, Special Secretary & Additional I.R. (Legal cell) Advocate General Office, Prayagraj regarding submission of statement of movable and immovable properties acquired/held by him or any member of his family of the financial years 2022-23 & 2023-24 in the prescribed proforma respectively to this Court for kind perusal and information as required by the Court.

In this connection, it is submitted that as per statement of movable and immovable properties for the financial years 2022-23 & 2023-24 of the officer concerned, details of income, deduction, savings investment and expenditure made by him are given below.

(1) In the financial years 2022-23 & 2023-24, Total income is Rs.1,13,60,576/- [total income from salary & arrears are Rs.1,10,10,637/-, Agricultural income of Rs.36,000/-, matured amount of L&T folio of Rs.42,570/-, Bank interests of Rs.2,71,369/-) and total deductions/ repayment/ savings/ investment against GIS, NPS, Income Tax, Insurance policies, PPF, Sukanya Samriddhi Yojna, Mutual fund, Shares, Home loan, car loan and the balance of his savings bank account(s) has been enhanced for Rs.39,06,815/- this financial year from previous year's balance, total of which is Rs.87,58,610/-. Thus, a sum of Rs.26,01,966/- was therefore available with him to meet out the household expenditure of his family consisting five members for both the financial years 2022-23 & 2023-24.

It is pertinent to mention here that her mother's annual pension is Rs.1,80,000/- approx.

In this connection it is submitted that he has submitted his property statement upto the financial year 2020-22 online, which has already been seen online by Hon'ble Mr. Justice Siddhartha Varma, Administrative Judge, Allahabad/Prayagraj Judgeship.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit his property statement for the financial years 2022-23 & 2023-24 in its next financial year i.e., 2024-25 upto March 2025. He has submitted movable and immovable property statements of the financial year 2022-23 & 2023-24 firstly vide online dated 12.09.2024. As such, there is no delay in submitting the same.
