May kindly see the property statement online received from Sri Saif Ahmad, Additional Principal Judge, Family Court, Kanpur Nagar regarding submission of statement of movable and immovable properties acquired/held by him or any member of his family of the financial years 2016-18 (2016-17 & 2017-18) in the prescribed proforma respectively to this Hon'ble Court for kind perusal and information as required by the Hon'ble Court.

In this connection, it is submitted that as per statement of movable and immovable properties for the financial years 2016-18 (2016-17 & 2017-18) of the officer concerned, details of income, deduction, savings investment and expenditure made by him are given below.

(1) In the financial years 2016-18 (2016-17 & 2017-18), Total income is Rs.25,29,833/- (Gross income from salary is Rs.25,02,116/-, and Bank Interest of Rs.27,717/- respectively) and total deductions/ repayment/ savings/ investment against Gis,Nps,Income tax,Ppf, Lic policy's,Life policy,Nsc is Rs.6,01,011/-. Thus, a sum of Rs.19,28,822/- was therefore available with him to meet out the household expenditure of his family consisting four members in both of the financial years and the balance of his savings bank account(s) is also decreased for Rs.1,94,468/- this financial year from previous year's balance.

In this connection, it is submitted that the Officer has already submitted his property statements of the financial year 2014-16 online against Case Id-P00008302021 and same has been moved before Hon'ble Mr. Justice Mahesh Chandra Tripathi, Administrative Judge, Kanpur Nagar for kind perusal & order.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit his property statement for the financial years 2016-18 (2016-17 & 2017-18) in its next financial year i.e., 2018-19 upto March 2019. He has submitted movable and immovable property statements of the financial years 2016-18 (2016-17 & 2017-18) vide online dated 09.11.2021. As such, there is delay in submitting the same. In this regards officer has stated that after the death of his father, his mother was suffering from old age illness. Due to day to day care of her he could not remember to send the property statement, for which he is seeking unconditional apologise for the delay.

May, therefore, if approved, property statements for the financial years 2016-18 (2016-17 & 2017-18) of Sri Saif Ahmad, Additional Principal Judge, Family Court, Kanpur Nagar be laid before Hon'ble Mr. Justice Mahesh Chandra Tripathi, Administrative Judge, Kanpur Nagar for His Lordship's kind perusal and orders.
