May kindly see the property statement online received from Sri Abhai Srivastava, Additional District & Sessions Judge, Sultanpur regarding submission of statement of movable and immovable properties acquired/held by him or any member of his family of the financial years 2018-19 & 2019-20 in the prescribed proforma respectively to this Court for kind perusal and information as required by the Court.

In this connection, it is submitted that as per statement of movable and immovable properties for the financial years 2018-19 & 2019-20 of the officer concerned, details of income, deduction, savings investment and expenditure made by him are given below.

(1) In the financial years 2018-19 & 2019-20, Total income is Rs.45,47,184/- [Gross salary (for both the financial years) is Rs.39,98,259/-, SB a/c interests of Rs.25,115/-, matured amount of STDR, LIC policies, NSC & Fund of Rs.63,551/-, Rs.1,41,515/-, Rs.63,680/- & Rs.2,55,064/-] and total deductions/ repayment/ savings/ investment against GIS, CPF, Income Tax, Ioan, LIC policies, SIP and PPF are Rs.22,72,232/-. Thus, a sum of Rs.22,74,952/- was therefore available with him to meet out the household expenditure of his family consisting four members for both the financial years 2018-19 & 2019-20. And the balance of his savings bank a/c is also reduced for Rs.3,01,314/- in this financial year from previous year's balance.

In this connection it is submitted that officer has already submitted his property statement upto the financial year 2015-16, which has already been seen by Hon'ble Mr. Justice Amit Sthalekar, the then Administrative Judge, Varanasi in the mIsc. file of the officer. And property statement of the financial years 2016-17 & 2017-18, a detailed note has been submitted before Hon'ble Siddhartha Varma, Administrative Judge, Sultanpur for kind perusal & order.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit his property statement for the financial years 2018-19 & 2019-20 in its next financial year i.e., 2020-21 upto March 2021. He has submitted movable and immovable property statements of the financial years 2018-19 & 2019-20 online dated 06.10.2020. As such, there is no delay in submitting the same from the part of the officer.

May, therefore, if approved, property statements for the financial years 2018-19 & 2019-20 of Sri Abhai Srivastava, Additional District & Sessions Judge, Sultanpur be laid before Hon'ble Mr. Justice Siddhartha Varma, Administrative Judge, Sultanpur Judgeship for His Lordship's kind perusal and orders?
