

## **Registrar(J)(Budget)**

May kindly see the property statement online received from Sri Vimlesh Saroj, Civil Judge (Senior Div.), Bareilly regarding submission of statement of movable and immovable properties acquired/held by him or any member of his family of the financial years 2016-18(2016-17 & 2017-18) in the prescribed proforma respectively to this Hon'ble Court for kind perusal and information as required by the Hon'ble Court.

In this connection, it is submitted that as per the statement of movable and immovable properties for the financial years 2016-18(2016-17 & 2017-18) of the officer concerned, details of income, deduction, savings investment and expenditure made by him are given below:

**(1) In the financial years 2016-18(2016-17 & 2017-18)**, Gross income from salary is Rs.10,11,382/- and total deductions/ repayment/ savings/ investment against GIS, NPS, Income Tax, PPF, Mutual Fund, Personal Loan EMI, Car Loan EMI, total of which is Rs.4,19,553/-. Thus, a sum of Rs.5,91,829/- was available with him to meet out the household expenditure of his family consisting of three members in both of the financial years and the balance of his savings bank account(s) is Decreased by Rs.23,451/- this financial year from previous year's balance

It is pertinent to mention here that his father is working as an advocate having monthly income Rs.20,000/-.

In this connection, it is submitted that the Officer has already submitted his property statements of at the time of Joining online on Case id-P00001622019 and same has been approved by the Hon'ble Mr. Justice Attau Rahman Masoodi, the then Administrative Judge, Bareilly Judgeship.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit his property statement for the financial years 2016-18(2016-17 & 2017-18) in its next financial year i.e., 2018-19 upto March 2019. He has submitted movable and immovable property statements of the financial years 2016-18 (2016-17 & 2017-18) vide online dated 15.02.2021. As such, there is delay in submitting the same. In this regard, Officer has stated that, in his verbatim as under:

*"Most humbly and respectfully submitted that the applicant in compliance of order of Hon'ble High Court, inadvertantly and bonafidely, submitted the property statement for the financial year 2017-18 instead of the property statement for financial year 2016-2018. However, through the objection of the Hon'ble High Court Admin Section, it was directed to withdraw the property statemet as submitted for financial year 2017-19 and to resubmit the property statement for the financial year 2016-2018. The applicant, further, in compliance of the Hon'ble direction withdrew the bonafidely submitted property statement with application Id-776 for the financial year 2017-2018 on dated 25/02/2020 and proceded to further resubmit the property statement for the financial year 2016-2018. which took some time in collecting the details and processing further for resubmission of property statement of respective financial year.*

*That on account of aforesaid reasons and facts, the underigned humbly request to Hon'ble High Court to condon the delay caused by the undersigned due to a bonafide mistake. The applicant will take utmost care and deligence in furture."*

In view of the above, it is submitted that the Officer has submitted property statements for the financial year 2017-2019 through online against Case Id : P00001892020 (Old Case Id : 776) on 26.02.2020. In the property statement, some requisite information were missing. Accordingly, as per two year block policy (as his joining date is 11.01.2017), the officer was asked to submit the movable and immovable property statements for the financial years 2016-2018 after mentioning required information instead of the financial year 2017-2019 and to withdraw application ID no.776, vide online objection dated 29.02.2020.

May, therefore, if approved, property statements for the financial years 2016-18(2016-17 & 2017-18) of Sri Vimlesh Saroj, Civil Judge (Senior Div.), Bareilly, be laid before Hon'ble Mr. Justice Ajit Kumar, Administrative Judge, Bareilly Judgeship for His Lordship's kind perusal and orders?
