May kindly see the property statement submitted online received from Sri Harish Tripathi, Principal Judge, Family Court, Bareilly regarding submission of statement of movable and immovable properties acquired/held by him or any member of his family for the financial years 2018-19 & 2019-20 in the prescribed proforma to this Court for kind perusal and information as required by the Court.

In this connection, it is submitted that as per statement of movable and immovable properties for the financial years financial years 2018-19 & 2019-20 of the officer concerned, details of income, deduction, savings investment and expenditure made by him are given below.

(1) In the financial years 2018-19 & 2019-20, Total income is Rs.76,14,286/- (Gross income is Rs.52,01,544/-, redemptions of Mutual Funds of Rs.6,29,319/- and matured amount of PPF a/c of Rs.17,83,423/-) and total deductions/ repayment/ savings/ investment (for both the financial years) against GPF, GIS, Income Tax, loans, Insurance policies, mutual funds and the balance of his savings accounts is enhanced for Rs.1,78,131/- this financial year from previous year's balance, total of which is Rs.62,05,861/-. Thus, a sum of Rs.14,08,425/- was therefore available with him to meet out the household expenditure of his family consisting four members in both of the financial years.

It is pertinent to mention here that his wife's annual income of Rs.90,000/- from agriculture and grove acquired by gift (Hiba) from her mother and his elder son is Judicial officer having annual income of approx. 10 lacs.

In this connection, it is submitted that the officer has already submitted his property statement upto the financial year 2017-18 which had already been seen by Hon'ble Mr. Justice Abhinava Upadhyaya, the then Administrative Judge, Bareilly.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit his property statement for the financial years 2018-19 & 2019-20 in its next financial year i.e., 2020-21 upto March 2021. He has submitted movable and immovable property statements of the financial years 2018-19 & 2019-20 firstly vide online dated 13.07.2020. As such, there is no delay in submitting the same.

May, therefore, if approved, property statements for the financial years 2018-19 & 2019-20 of Sri Harish Tripathi, Principal Judge, Family Court, Bareilly be laid before Hon'ble Mr. Justice Attau Rahman Masoodi, Administrative Judge, Bareilly Judgeship for His Lordship's kind perusal and order?
