In this connection, it is submitted that as per statement of movable and immovable properties for the financial years 2018-19 & 2019-20 of the officer concerned, details of income, deduction, savings investment and expenditure made by him are given below.

(1) In the financial years 2018-19 & 2019-20, Total income from salary & assets is Rs.55,64,614/- and total deductions/ repayment/ savings/ investment (for both the financial years) against GPF, GIS, Income Tax, Home loan, PPF, Insurance policies and the balance of his savings bank account(s) is enhanced for Rs.2,74,664/- this financial year from previous year's balance, total of which is Rs.31,98,447/-. Thus, a sum of Rs.23,66,167/- was therefore available with him to meet out the household expenditure of his family consisting four members in both the financial years.

It is pertinent to mention here that his wife is working with Aricent group of companies & Concentrix India Services Ltd. at Gurgaon, Haryana as a Vice-President having monthly income of Rs.7 lacs and his daughter is working with Deutsche bank, Mumbai since July, 2019 having monthly income of Rs.1 lac.

In this connection, it is submitted that officer has already submitted his property statement upto the financial year 2017-18, which had already been seen by Hon'ble Mr. Justice Pankaj Naqvi, the then Administrative Judge, Budaun in the misc. file of the officer.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit his property statement of the financial years 2018-19 & 2019-20 in its next financial year i.e., 2020-21 upto March 2021. He has submitted movable and immovable property statements of the financial years 2018-19 & 2019-20 firstly vide online dated 07.07.2020. As such, there is no delay in submitting the same for no reason has been mentioned by the officer concerned.

May, therefore, if approved, property statements of the financial year 2018-19 & 2019-20 of Sri Narendra Kumar-IV, Principal Judge, Family Court, Saharanpur be laid before Hon'ble Mr. Justice Rajiv Gupta, Administrative Judge, Saharanpur for His Lordship's kind perusal and orders?
