May kindly see the property statement online received from Sri Ankur Garg, Civil Judge (Sr. Div.), Lucknow regarding submission of statement of movable and immovable properties acquired/held by him or any member of his family of the financial years 2017-19 (2017-18 & 2018-19) in the prescribed proforma respectively to this Hon'ble Court for kind perusal and information as required by the Hon'ble Court.

In this connection, it is submitted that as per the statement of movable and immovable properties for the financial years 2017-19 (2017-18 & 2018-19) of the officer concerned, details of income, deduction, savings investment and expenditure made by him are given below:

(1) In the financial years 2017-19 (2017-18 & 2018-19), Gross income (Rs.24,90,030/- from salary & Rs. 4,21,311/- from other sources i.e. Maturity of NSC, Interest earned from NSCs etc.) Rs.24,90,030/- and total deductions/savings/ investment against NPS, GIS, PPF, Income Tax, Repayment of Car loan, Gold ornaments and Sukanya Samridhi Yojna is Rs.8,83,806/-. Thus a sum of Rs.16,51,724/-/- was therefore available with him to meet out the household expenditure of his family consisting of three members in the financial year 2017-19 (2017-18 & 2018-19) and the balance of his savings account is also decreased for Rs.70,704/- this financial year from previous year balance.

It is pertinent mention here that's Officer's wife (Tution and dance classes) having annual income Rs.2,88,509/- and Rs.2,89,028/- respectively during financial year.

In this connection, it is submitted that the Officer has already submitted his property statement of the financial year 2016-17, which has been seen by Hon'ble Mr. Justice B. Amit Sthalekar, the then ,Administrative Judge, Kasganj in the Misc. file of the officer.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit his property statement for the financial years 2017-19 (2017-18 & 2018-19) in its next financial year i.e., 2019-20 upto March 2020. He has submitted movable and immovable property statements of the financial year 2017-19 (2017-18 & 2018-19) vide online dated 07.01.2021. As such, there is delay in submitting same, in this regard officer has not given any reason.

May, therefore, if approved, property statements for the financial years 2017-19 (2017-18 & 2018-19) of Sri Ankur Garg, Civil Judge (Sr. Div.), Lucknow be laid before Hon'ble Mr. Justice Vivek Kumar Birla, Administrative Judge, Lucknow for His Lordship's kind perusal and orders?
