In this connection, it is submitted that as per statement of movable and immovable properties for the financial years 2018-19 & 2019-20 of the officer concerned, details of income, deduction, savings investment and expenditure made by him are given below.

(1) In the financial years 2018-19 & 2019-20, Gross income from salary (for both the financial years) is Rs.35,38,093/- and total deductions/ repayment/ savings/ investment against PPF, GIS, LIP, CPF, Income Tax and loans are Rs.21,40,298/-. Thus, a sum of Rs.13,97,795/- was therefore available with him to meet out the household expenditure of his family consisting four members for both the financial years 2018-19 & 2019-20. And the balance of his savings bank account(s) is also reduced for Rs.4,02,478/- this financial year from previous year's balance.

It is pertinent to mention here that his wife is Additional District & Sessions Judge, Agra having monthly income of Rs.1,50,000/-.

In this connection, it is submitted that officer has already submitted his property statement upto the financial year 2017-18, which has already been seen by Hon'ble Mr. Justice Munishwar Nath Bhandari, the then Administrative Judge, Agra in the mIsc. file of the officer.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit his property statement for the financial years 2018-19 & 2019-20 in its next financial year i.e., 2020-21 upto March 2021. He has submitted movable and immovable property statements of the financial years 2018-19 & 2019-20 vide online dated 21.09.2020. As such, there is no delay in submitting the same from the part of the officer.

May, therefore, if approved, property statements for the financial years 2018-19 & 2019-20 of Sri UmaKant Jindal, Spl. J. (SC/ST, Pev.of Atroci Act), Hapur be laid before Hon'ble Mrs. Justice Saroj Yadav, Administrative Judge, Hapur Judgeship for Her Lordship's kind perusal and orders?
