May kindly see the property statement online received from Sri Akhilesh Kumar Pandey, Additional District & Sessions Judge, Fatehpur regarding submission of statement of movable and immovable properties acquired/held by him or any member of his family of the financial years 2018-20 (2018-19 & 2019-20) in the prescribed proforma respectively to this Hon'ble Court for kind perusal and information as required by the Hon'ble Court.

In this connection, it is submitted that as per the statement of movable and immovable properties for the financial years 2018-20 (2018-19 & 2019-20) of the officer concerned, details of income, deduction, savings investment and expenditure made by him are given below:

In the financial years 2018-20 (2018-19 & 2019-20), his gross income from salary and other sources is Rs.52,68,786/- (Rs.46,03,692 from salary, Rs.3,94,000/- from withdrawal from PPF, Rs.9,890/- from saving bank account interest, Rs.2,220/- from Income Tax Return and Rs.2,58,984/- from PPF withdrawal) and total deductions/Savings/investments against Savings in Bank account, GPF, GIS, Income Tax, Repayment of Home loan advance amount, Insurance and PPF is Rs.33,43,492/-. The balance of Rs.2,148/- has increased from his saving bank A/c's against the balance of the previous year. Thus a sum of Rs.19,25,294/- was therefore available with him to meet out the household expenditure of his family consisting four members in the financial years 2018-20 (2018-19 & 2019-20).

In this connection, it is submitted that the Officer has already submitted his property statement up to the financial years 2016-18 (2016-17 & 2017-18) in offline mode, which has been already seen by Hon'ble Mr. Justice Narendra Kumar Johari, Administrative Judge, Fatehpur Judgeship in the Misc. file of the officer.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit his property statement for the financial years 2018-20 (2018-19 & 2019-20) in its next financial year i.e., 2020-21 upto March 2021. He has submitted movable and immovable property statements for the financial years 2018-20 (2018-19 & 2019-20) vide online dated 10.07.2020. As such, there is no delay submitting the same.

May, therefore, if approved, property statements for the financial years 2018-20 (2018-19 & 2019-20) of Sri Akhilesh Kumar Pandey, Additional District & Sessions Judge, Fatehpur be laid before Hon'ble Mr. Justice Narendra Kumar Johari, Administrative Judge, Fatehpur Judgeship for His Lordship's kind perusal and orders?
