May kindly see the property statement submitted online received from Sri Aashish Pandey, Additional Civil Judge, (Sr. Div.)/ACJM, Etawah, regarding submissions of statement of movable and immovable properties acquired/held by him or any member of his family for the financial year 2016-18 (2016-17 & 2017-18) in the prescribed proforma respectively to this Court for kind perusal and information as required by the Court.

In this connection, it is submitted that as per statements of movable and immovable properties for the financial years 2016-18 (2016-17 & 2017-18) of the officer concerned, details of income, deductions, savings, investment and expenditure made by him are given below.

In the financial year 2016-18 (2016-17 & 2017-18), his Total income from salary is Rs. 9,71,250/- and total deductions/savings/investments against NPS, GIS, Income tax, and car loan are Rs. 4,31,380/- (including enhancement of Rs. 2,30,139 in his S.B. A/cs against the balance of the previous year) Thus a sum of Rs. 7,70,009/- was therefore available with him to meet out the household expenditure of his family consisting of three members in both the financial years.

In this connection, it is submitted that the officer has already submitted his property statements online at the time of joining which is also processed online before Hon'ble Mr. Justice Raj Beer Singh, Administrative Judge, Etawah, on e-service Id no 1301.

It is further submitted that as per policy/Court's Circular letter, the officer has to submit his property statements for the financial year 2016-18 (2016-17 & 2017-18) in its next financial year i.e., 2018-19 upto March 2019. He has submitted movable and immovable property statements for the financial years 2016-18 (2016-17 & 2017-18) firstly vide online dated 25.08.2020. As such, there is delay in submitting the same from the part of the officer for which the officer has stated that due to the unawareness on his part he had sent his property statement on 08.04.2019 but that was not in accordance with procedure. He further stated that there is delay in sending property statement separately for each financial year. He beg pardoned for his ignorance and mistake and ensured that in future there will not be any such delay or mistake.

May, therefore, if approved, property statements for the financial year 2016-18 (2016-17 & 2017-18) of Sri Aashish Pandey, Additional Civil Judge, (Sr. Div.)/ACJM, Etawah, be laid before Hon'ble Mr. Justice Raj Beer Singh, Administrative Judge, Etawah Judgeship, for his Lordship's kind perusal and order?
