May kindly see the property statement submitted online received from Sri Amit Pal Singh, Principal Judge, Family Court, Hapur regarding submission of statement of movable and immovable properties acquired/held by him or any member of his family for the financial year 2012-14 (2012-13 & 2013-14) in the prescribed proforma respectively to this Hon'ble Court for kind perusal and information as required by the Court.

In this connection, it is submitted that as per statements of movable and immovable properties for the financial years 2012-14 (2012-13 & 2013-14) of the officer, concerned, details of income, deductions, savings, investment and expenditure made by him are given below.

In the financial year 2012-14 (2012-13 & 2013-14), his Total income from salary and other source is Rs. 35,73,654/- (Total Salary Rs. 35,53,654/- and LIC return Rs. 20,000) and total deductions/savings/investments against GPF, GIC, Income Tax, PPF, LIC, Section 80b and Loan LIC HFL and the balance of his Saving bank A/c is enhanced for Rs. 8,06,680/- this financial year from previous year's balance, total of which is Rs. 24,31,196/-. Thus a sum of Rs. 11,42,458/- was therefore available with him to meet out the household expenditure of his family consisting of four members in both the financial years.

It is pertinent to mention here that the Officer has Joint family income from ancestral agricultural land.

In this connection, it is submitted that the officer has already submitted his property statements offline for the financial year 2011-12 and seen by Hon'ble Mr. Justice Dilip Gupta, the then Administrative Judge, Allahabad.

It is further submitted that as per policy/Court's Circular letter, the officer has to submit his property statements for the financial year 2012-14 (2012-13 & 2013-14) in its next financial year i.e., 2014-15 upto 31st March 2015. He has submitted movable and immovable property statements for the financial years 2012-14 (2012-13 & 2013-14) firstly vide his application dated 03.08.2020. As such, there is delay in submitting the same from the part of the officer and he has not given any reason for delay.

May, therefore, if approved, property statements for the financial years 2012-14 (2012-13 & 2013-14) of Sri Amit Pal Singh, Principal Judge, Family Court, Hapur be laid before Hon'ble Mr. Justice Ashutosh Srivastava, Administrative Judge, Hapur, for His Lordship's kind perusal and order?
