

## **Registrar(Judicial)(Budget)**

May kindly see the property statement submitted online received from Sri Amit Pal Singh, presently posted as Principal Judge, Family Court, Jalaun at Orai, regarding submission of statement of movable and immovable properties acquired/held by him or any member of his family for the financial year 2016-18 (2016-17 & 2017-18) in the prescribed proforma respectively to this Hon'ble Court for kind perusal and information as required by the Court.

In this connection, it is submitted that as per statements of movable and immovable properties for the financial years 2016-18 (2016-17 & 2017-18) of the officer, concerned, details of income, deductions, savings, investment and expenditure made by him are given below.

In the financial year 2016-18 (2016-17 & 2017-18), his Total income is Rs. 57,05,955/- . (This includes his salary as Rs. 36,72,256/-, 2 separate LIC insurance payouts as Rs. 2,11,700/- & Rs. 1,42,000/- and income from rent as Rs. 16,80,000/-). After total deductions/savings/investments against GIS, GPF, Income Tax, Insurance Policies, PPF, loan and the balance of his Savings bank A/c is enhanced for Rs. 6,32,410/- this financial year from previous year's balance, total of which is Rs. 22,76,291/-. Thus a sum of Rs.34,29,664/- was therefore available with him to meet out the household expenditure of his family consisting of four members in both the financial years.

It is pertinent to mention here that in he has only mentioned joint family income from ancestral agricultural land but has not quoted any amount for the same.

In this connection, it is submitted that the officer has already submitted his property statements for 2010-12 which was seen by Hon'ble Mr. Justice Dilip Gupta, the then Administrative Judge, Allahabad.

The property statement for 2012-14 & 2014-16 has already been processed under ID No. 1271 & 1273 respectively and has been laid before Hon'ble Mr. Justice Ashutosh Srivastava, Administrative Judge, Hapur, for His Lordship's kind perusal and order?.

It is further submitted that as per policy/Court's Circular letter, the officer has to submit his property statements for the financial year 2016-18 (2016-17 & 2017-18) in its next financial year i.e., 2018-19 upto 31st March 2019. He has submitted movable and immovable property statements for the financial years 2016-18 (2016-17 & 2017-18) firstly vide his application dated 03.08.2020. As such, there is a significant delay in submitting the same from the part of the officer and the officer has not submitted any reason for the same.

May, therefore, if approved, property statements for the financial years 2016-18 (2016-17 & 2017-18) of Sri Amit Pal Singh, presently posted as Principal Judge, Family Court, Hapur, be laid before Hon'ble Mr. Justice Ashutosh Srivastava, Administrative Judge, Hapur for His Lordship's kind perusal and orders?
