May kindly see the property statement submitted online received from Sri Amit Pal Singh, presently posted as Principal Judge, Family Court, Hapur, regarding submission of statement of movable and immovable properties acquired/held by him or any member of his family for the financial year 2014-16 (2014-15 & 2015-16) in the prescribed proforma respectively to this Hon'ble Court for kind perusal and information as required by the Court.

In this connection, it is submitted that as per statements of movable and immovable properties for the financial years 2014-16 (2014-15 & 2015-16) of the officer, concerned, details of income, deductions, savings, investment and expenditure made by him are given below.

In the financial year 2014-16 (2014-15 & 2015-16), his Total income is Rs. 53,29,291/- . (This includes his salary as Rs. 33,39,545/-, interests on savings bank as Rs. 82,746/-, LIC's return Rs. 287000/- and income from rent as Rs. 16,20,000/-) and deductions/savings/investments against GIC, GPF, Income Tax, Insurances, PPF, LIC HFL loan and the balance of his Savings bank A/c is enhanced for Rs. 12,36,731/- this financial year from previous year's balance, total of which is Rs. 33,30,010/-. Thus a sum of Rs. 19,99,281/- was therefore available with him to meet out the household expenditure of his family consisting of four members in both the financial years.

It is pertinent to mention here that the officer has only mentioned joint family income from ancestral agricultural land but has not quoted any amount for the same.

In this connection, it is submitted that the property statement upto the financial years 2012-14 has already been processed online and laid before Hon'ble Mr. Justice Ashutosh Srivastava, Administrative Judge, Hapur, for His Lordship's kind perusal and orders under e-service ID No. 1271.

It is further submitted that as per policy/Court's Circular letter, the officer has to submit his property statements for the financial year 2014-16 (2014-15 & 2015-16) in its next financial year i.e., 2016-17 upto 31st March 2017. He has submitted movable and immovable property statements for the financial years 2014-16 (2014-15 & 2015-16) firstly vide his application dated 03.08.2020. As such, there is delay in submitting the same from the part of the officer for which officer has prayed for condonation of delay in submission of property statement which could not be submitted within time.

May, therefore, if approved, property statements for the financial years 2014-16 (2014-15 & 2015-16) of Sri Amit Pal Singh, presently posted as Principal Judge, Family Court, Hapur, be laid before Hon'ble Mr. Justice Ashutosh Srivastava, Administrative Judge, Hapur for His Lordship's kind perusal and orders?
