May kindly see the property statement received from Smt. Vijay Raje Sisodia, the then Additional District & Sessions Judge, Kanpur Nagar presently posted as Additional Principal Judge, Family Court, Kanpur Nagar regarding submission of statement of movable and immovable properties acquired/held by her or any member of her family for the financial years 2018-19 & 2019-20 in the prescribed proforma respectively to this Court for kind perusal and information as required by the Court.

In this connection, it is submitted that as per statement of movable and immovable properties for the financial years 2018-19 & 2019-20 of the officer concerned, details of income, deduction, savings investment and expenditure made by her are given below.

(1) In the financial years 2018-19 & 2019-20, Total Income is Rs.45,44,035/- and total deductions/ repayment/ savings/ investments (for both the financial years) against GPF, GIS, LIC, PLI, PPF, Income Tax and the balance of her savings bank account(s) is enhanced for Rs.1,13,445/- this financial year from previous year's balance, total of which is Rs.18,22,998/-. Thus, a sum of Rs.27,21,037/- was therefore available with her to meet out the household expenditure of her family consisting of four members in whole of the financial year.

It is pertinent to mention here that her husband is in Judicial Service (H.J.S.) having annual income of Rs.15,07,559/- & Rs.13,67,596/- in the financial years 2018- 19 & 2019-20 respectively.

In this connection, it is submitted that officer has already submitted her property statement upto the financial year submitted her property statement upto the financial year 2009-10 which had already been seen by Hon'ble Mr. Justice Abdul Mateen, the then Administrative Judge, Lucknow in the misc. file of the officer. And of the financial years 2010-11 to 2017-18, a detailed note has been submitted before Hon'ble Mrs. Justice Sunita Agarwal, Administrative Judge, Kanpur Nagar Judgeship for Her Lordship's kind perusal and orders (in the misc. file of the officer).

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit her property statements of the financial years 2018-19 & 2019-20 in its next financial year i.e., 2020-21 upto March 2021. She has submitted movable and immovable property statements of the financial years 2018-19 & 2019-20 firstly vide online dated 06.10.2020. As such, there is no delay in submitting the same.

May, therefore, if approved, property statements of the financial year 2018-19 & 2019-20 of Smt. Vijay Raje Sisodia, presently posted as Additional Principal Judge, Family Court, Kanpur Nagar be laid before Hon'ble Mr. Justice Mahesh Chandra Tripathi, Administrative Judge, Kanpur Nagar Judgeship for His Lordship's kind perusal and orders?
