May kindly see the property statement submitted online received from Sri Shiv Kumar III, presently posted as Special Judge, Special Court No. 2 (Pre. Cor. Act), Bareilly, regarding submission of statement of movable and immovable properties acquired/held by him or any member of his family for the financial year 2012-14 (2012-13 & 2013-14) in the prescribed proforma respectively to this Hon'ble Court for kind perusal and information as required by the Hon'ble Court.

In this connection, it is submitted that as per statements of movable and immovable properties for the financial years 2012-14 (2012-13 & 2013-14) of the officer, concerned, details of income, deductions, savings, investment and expenditure made by him are given below.

In the financial year 2012-14 (2012-13 & 2013-14), his Total income from salary and others sources is Rs. 17,87,648/-. (Total salary Rs. 17,32,658/-, 2 separate RD redemption of a total of Rs. 54,990/-). The total deductions/savings/investments against NPS, GIS, Income Tax, Insurance Policies, PPF, Loan, & RD is Rs. 11,41,366/-. Thus a balance of Rs. 8,41,662/- was therefore available with him to meet out the household expenditure of his family consisting of six members in both the financial years. And the balance of his Savings bank A/c is reduced by Rs. 1,95,380/- this financial year from previous year's balance.

It is pertinent to mention here that in his father receives a monthly pension of Rs. 24,000/-.

In this connection, it is submitted that the officer has already submitted his property statements for 2010-12 which already been seen by Hon'ble Mr. Justice Mr. S. S. Chauhan, the then Administrative Judge, Budaun Judgeship.

It is further submitted that as per policy/Court's Circular letter, the officer has to submit his property statements for the financial year 2012-14 (2012-13 & 2013-14) in its next financial year i.e., 2014-15 upto 31st March 2015. He has submitted movable and immovable property statements for the financial years 2012-14 (2012-13 & 2013-14) firstly vide his application dated 12.08.2020. As such, there is a delay in submitting the same from the part of the officer and he has not submitted any reason for the same.

May, therefore, if approved, property statements for the financial years 2012-14 (2012-13 & 2013-14) of Sri Shiv Kumar III, presently posted as Special Judge, Special Court No. 2 (Pre. Cor. Act), Bareilly be laid before Hon'ble Mr. Justice Attau Rahman Masoodi, Administrative Judge, Bareilly Judgeship for His Lordship's kind perusal and orders?
