May kindly see the property statement submitted online received from Sri Shiv Kumar III, presently posted as Special Judge, Special Court No. 2 (Pre. Cor. Act), Bareilly, regarding submission of statement of movable and immovable properties acquired/held by him or any member of his family for the financial year 2016-18 (2016-17 & 2017-18) in the prescribed proforma respectively to this Hon'ble Court for kind perusal and information as required by the Court.

In this connection, it is submitted that as per statements of movable and immovable properties for the financial years 2016-18 (2016-17 & 2017-18) of the officer, concerned, details of income, deductions, savings, investment and expenditure made by him are given below.

In the financial year 2016-18 (2016-17 & 2017-18), his Total income from salary is Rs. 32,70,195/-, (Total salary Rs. 30,44,979/-, 2 policies of LIC maturity total of Rs. 1,26,166/- and 3 NSC maturity total of Rs. 99,050/-). The total deductions/savings/investments against GIS, GPF, Income Tax, Insurances, PPF, Loan the balance of his Savings bank A/c is enhanced for Rs. 2,86,011/- this financial year from previous year's balance, total of which is Rs. 22,25,220/-. Thus a sum of Rs. 10,44,975/- was therefore available with him to meet out the household expenditure of his family consisting of four members in both the financial years.

It is pertinent to mention here that his father receives a monthly pension of Rs. 24,000/-. In this connection, it is submitted that the officer has already submitted his property statements online for the financial years 2014-16 (2014-15 & 2015-16) which is also processed online and laid before Hon'ble Mr. Attau Rahman Masoodi, Administrative Judge, Bareilly Judgeship for kind perusal and order on e-service Id. no. 1303.

It is further submitted that as per policy/Court's Circular letter, the officer has to submit his property statements for the financial year 2016-18 (2016-17 & 2017-18) in its next financial year i.e., 2018-19 upto 31st March 2019. He has submitted movable and immovable property statements for the financial years 2016-18 (2016-17 & 2017-18) firstly vide his application dated 12.08.2020. As such, there is a delay in submitting the same from the part of the officer and he has not submitted any reason for the same.

May, therefore, if approved, property statements for the financial years 2016-18 (2016-17 & 2017-18) of Sri Shiv Kumar III, presently posted as Special Judge, Special Court No. 2 (Pre. Cor.
