May kindly see the property statement submitted online received from Sri Shiv Kumar III, presently posted as Additional District & Sessions Judge (F.T.C.), Baghpat regarding submission of statement of movable and immovable properties acquired/held by him or any member of his family for the financial year 2018-20 (2018-19 & 2019-20) in the prescribed proforma respectively to this Hon'ble Court for kind perusal and information as required by the Court.

In this connection, it is submitted that as per statements of movable and immovable properties for the financial years 2018-20 (2018-19 & 2019-20) of the officer, concerned, details of income, deductions, savings, investment and expenditure made by him are given below.

In the financial year 2018-20 (2018-19 & 2019-20), his Total income from salary & other sources is Rs. 38,40,784/-, (Income from salary Rs.37,93,384/- and income from NSC maturity total of Rs.47,400/-). The total deductions/savings/investments against GIS, NPS, Income Tax, Insurances, PPF, repayment of home & car loan, total of which is Rs.25,01,665/-. Thus a sum of Rs.13,39,119/- was therefore available with him to meet out the household expenditure of his family consisting of four members in both the financial years. And the balance of his Savings bank A/c is reduced for Rs.44,086/- this financial year from previous year's balance.

It is pertinent to mention here that his father receives a monthly pension of Rs. 24,000/-.

In this connection, it is submitted that the officer has already submitted his property statements online for the financial years 2016-18 (2016-17 & 2017-18) which is also seen online by Hon'ble Mr. Attau Rahman Masoodi, the then Administrative Judge, Bareilly Judgeship for kind perusal and order on e-service Id. no. 1304.

It is further submitted that as per policy/Court's Circular letter, the officer has to submit his property statements for the financial year 2018-20 (2018-19 & 2019-20) in its next financial year i.e., 2020-21 upto 31st March 2021. He has submitted movable and immovable property statements for the financial years 2018-20 (2018-19 & 2019-20) firstly vide his application dated 12.08.2020. As such, there is no delay in submitting the same from the part of the officer.

May, therefore, if approved, property statements for the financial years 2018-20 (2018-19 & 2019-20) of Sri Shiv Kumar III, presently posted as Additional District & Sessions Judge (F.T.C.), Baghpat be laid before Hon'ble Mr. Justice Vikram D Chauhan, Administrative Judge, Baghpat Judgeship for His Lordship's kind perusal and orders?
