May kindly see the property statement submitted online dated 08.01.2021 received from SriRupesh Ranjan, the then Additional District & Sessions Judge, Sitapur presently posted as Principal Judge, Family Court, Mahoba regarding submission of statement of movable and immovable properties acquired/held by him or any member of his family for the financial year 2015-16 & 2016-17 in the prescribed proforma respectively to this Court for kind perusal and information as required by the Court.

In this connection, it is submitted that as per statement of movable and immovable properties for the financial years 2015-16 & 2016-17 of the officer concerned, details of income, deduction, savings investment and expenditure made by him are given below.

(1) In the financial year 2015-16 & 2016-17, income from salary is Rs.30,52,220/- and total deductions/ repayment/ savings/ investment (for both the financial years) against GIS, CPF/NPS, Income Tax, LIC policy, PPF, Mutual fund and the balance of his savings bank account(s) is enhanced for Rs.5,39,139/- this financial year from previous year's balance, total of which is Rs.15,85,658/-. Thus, a sum of Rs.14,66,562/- was therefore available with him to meet out the household expenditure of his family consisting two members in both the financial years.

In this connection, it is submitted that the officer has submitted online his property statement at the time of joining, which has already been seen online by Hon'ble Mr. Justice Pankaj Naqvi, the then Administrative Judge, Sitapur and of the financial years 2013-14 & 2014-15, a separate note has been made on case-id no.1318.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit his property statement of the financial years 2015-16 & 2016-17 in its next financial year i.e., 2017-18 upto March 2018. He has submitted movable and immovable property statements of the financial years 2015-16 & 2016-17 firstly vide online dated 29.10.2020. As such, there is delay in submitting the same from the part of the officer for which he has stated that "since his wife was continuously facing health issues and was under treatment at Delhi and other places for which he had to frequently travel and also because of his engagement with regular judicial work he was unable to compile his property statement on time. He apologise for the delay and it will not be repeated in future" mentioned in remark column.

May, therefore, if approved, property statements of the financial year 2015-16 & 2016-17 of Sri Rupesh Ranjan, presently posted as Principal Judge, Family Court, Mahoba be laid before Hon'ble Mr. Justice Ajai Kumar Srivastava-I, Administrative Judge, Mahoba Judgeship for His Lordship's kind perusal and orders?
