May kindly see the property statements online received from Sri Anubhava Dwivedi, Additional District & Sessions Judge, Varanasi regarding submission of statement of movable and immovable properties acquired/held by him or any member of his family for the financial year 2017-18 & 2018-19 in the prescribed proforma respectively to this Court for kind perusal and information as required by the Court.

In this connection, it is submitted that as per statement of movable and immovable properties for the financial years 2017-18 & 2018-19 of the officer concerned, details of income, deduction, savings investment and expenditure made by him are given below.

(1) In the financial years 2017-18 & 2018-19, Total income is Rs.30,76,038/- (income from salary is Rs.29,03,663/- and FD interests of Rs.1,72,375/-) and total deductions/ repayment/ savings/ investment against GIS, Income Tax, PPF a/cs, insurance policies, NPS, Sukanya Samriddhi Yojna, Mutual funds and the balance of his savings bank account(s) is enhanced for Rs.41,568/- this financial year from previous year's balance, total of which is Rs.17,17,905/-. Thus, a sum of Rs.13,58,133/- was therefore available with him to meet out the household expenditure of his family consisting three members in both the financial years.

In this connection, it is submitted that the officer has already submitted his property statement at the time of joining into judicial service which had already been seen by Hon'ble Mr. Justice Abdul Mateen, the then Administrative Judge, Lucknow and of the financial years 2009-10 to 2016-17, detailed offline office note has been laid before Hon'ble Dr. Justice Kaushal Jayendra Thaker, the then Administrative Judge, Varanasi Judgeship for His Lordship's kind perusal and orders, in the misc. file of the officer.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit his property statement for the financial year 2017-18 & 2018-19 in its next financial year i.e., 2019-20 upto March, 2020. He has submitted movable and immovable property statements for the financial years 2017-18 & 2018-19 vide online dated 13.08.2020. As such, there is delay in submitting the same.

May, therefore, if approved, property statements for the financial year 2017-18 & 2018-19 of Sri Anubhava Dwivedi, Additional District & Sessions Judge, Varanasi be laid before Hon'ble Mr. Justice Siddhartha Varma, Administrative Judge, Varanasi Judgeship for His Lordship's kind perusal and orders?
