May kindly see the property statement online received from Smt. Poonam-II, Addl. District & Sessions Judge, Unnao regarding submission of statement of movable and immovable properties acquired/held by her or any member of her family of the financial years 2019-21 (2019-20 & 2020-21) in the prescribed proforma respectively to this Hon'ble Court for kind perusal and information as required by the Hon'ble Court.

In this connection, it is submitted that as per the statement of movable and immovable properties for the financial years 2019-21 (2019-20 & 2020-21) of the officer concerned, details of income, deduction, savings investment and expenditure made by her are given below:

**In the financial years 2019-21 (2019-20 & 2020-21)**, Total income is Rs.41,26,280/- (Gross income from salary is Rs.40,51,280/- and LIC Return for Rs.75,000/-) and total deductions/ repayment/ savings/ investment against GIS, PPF, LIC, SSA, NPS, Income Tax, Home Loan EMI, total of which is Rs.17,45,817/-. Thus, a sum of Rs.23,80,463/- was available with her to meet out the household expenditure of her family consisting of three members in both of the financial years and the balance of her savings bank account(s) is decreased by Rs.80,359/- this financial year from previous year's balance

It is pertinent to mention here that her husband is posted as Additional District Judge.

In this connection, it is submitted that the Officer has already submitted her property statements of the F.Y. 2017-19 (2017-18 & 2018-19) offline and same has been approved by the Hon'ble Mr. Justice Ramesh Sinha, the then, Administrative Judge, Shahjahanpur Judgeship in Misc. file of the Officer.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit her property statement for the financial years 2019-21 (2019-20 & 2020-21) in its next financial year i.e., 2021-22 upto March 2022. She has submitted movable and immovable property statements of the financial years 2019-21 (2019-20 & 2020-21) vide online dated 09.12.2021. As such, there is no delay in submitting the same.

May, therefore, if approved, property statements for the financial years 2019-21 (2019-20 & 2020-21) of Smt. Poonam-II, Addl. District & Sessions Judge, Unnao, be laid before Hon'ble Mr. Justice Rajiv Gupta, Administrative Judge, Unnao for His Lordship's kind perusal and orders?
