May kindly see the property statements submitted online dated 09.11.2020 received from Sri Anil Kumar Vashistha, the then Special Judge (SC/ST, Pev. Of Atroci Act), Moradabad presently posted as Special Judge (SC/ST, Pev. Of Atroci Act), Sant Kabir Nagar regarding submission of statement of movable and immovable properties acquired/held by him or any member of his family for the financial year 2016-17 & 2017-18 in the prescribed proforma respectively to this Court for kind perusal and information as required by the Court.

In this connection, it is submitted that as per statement of movable and immovable properties for the financial years 2016-17 & 2017-18 of the officer concerned, details of income, deduction, savings investment and expenditure made by him are given below.

(1) In the financial year 2016-17 & 2017-18, total income (including matured amount of FDRs, LIC policies, amount transferred from the a/c of his deceased mother, pension & agricultural income by mother) is Rs.53,73,817/- and total deductions/ repayment/ savings/ investment (for both the financial years) against GIS, GPF, Income Tax, PLI, Insurance policies, PPF a/c, maintenance to his wife & children and the balance of his savings bank account(s) is enhanced for Rs.28,78,459/- this financial year from previous year's balance, total of which is Rs.48,47,225/-. Thus, a sum of Rs.5,26,592/- was therefore available with him to meet out the household expenditure of himself in both the financial years.

In this connection it is submitted that the officer has already submitted his property statement upto the financial year 2015-16 which had already been seen by Hon'ble Mr. Justice Om Prakash-VII, the then Administrative Judge, Bahraich in the misc. file of the officer.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit his property statement for the financial year 2016-17 & 2017-18 in its next financial year i.e., 2018-19 upto march 2019. He has submitted property statements for the financial years 2016-17 & 2017-18 vide online dated 20.08.2020, As such, there is delay in submitting the same from the part of the officer for which he has stated that he could not sent the property statement of the financial year 2016-17 & 2017-18, within time due to family dispute. He is extremely regretful for delay in submission of statement in his reply dated 09.11.2020.

May, therefore, if approved, property statements for the financial year 2016-17 & 2017-18 of Sri Anil Kumar Vashistha, Special Judge (SC/ST, Pev. Of Atroci Act), Sant kabir Nagar be laid before Hon'ble Mr. Justice Om Prakash Tripathi, Administrative Judge, Sant Kabir Nagar Judgeship for His Lordship's kind perusal and orders?
