May kindly see the property statement online received from Sri Gajendra Kumar, District & Sessions Judge, Banda regarding submission of statement of movable and immovable properties acquired/held by him or any member of his family for the financial year 2018-20 in the prescribed proforma respectively to this Court for kind perusal and information as required by the Court.

In this connection, it is submitted that as per statement of movable and immovable properties for the financial years 2018-20 of the officer concerned, details of income, deduction, savings investment and expenditure made by him are given below-

(1) In the financial years 2018-20 (2018-19 & 2019-20), Total income is Rs.54,89,856/- (Gross income is Rs.54,77,041/- and SB a/cs interest of Rs.12,815/-) and total deductions/ repayment/ savings/ investment against GIS, GPF, Income Tax, LIC policies, Home loan, PPF a/c and the balance of his savings bank account(s) is enhanced for Rs.3,31,307/- this financial year from previous year's balance, total of which is Rs.29,38,934/-. Thus, a sum of Rs.25,50,922/- was therefore available with him to meet out the household expenditure of his family consisting four members in both the financial years.

It is pertinent to mention here that his wife's annual income of Rs.1,45,640/- and Rs.7,78,983/- from Self-Employed (mentioned Tuition in earlier submitted statements, in the misc. file of the officer).

In this connection it is submitted that officer has already submitted his property statement upto the financial year 2017-18, which has already been seen by Hon'ble Mr. Justice Karunesh Singh Pawar, Administrative Judge, Banda, in the misc. file of the officer.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit his property statement for the financial year 2018-19 & 2019-20 in its next financial year i.e., 2020-21 upto March 2021. He has submitted movable and immovable property statements for the financial years 2018-20 firstly vide online dated 21.08.2020. As such, there is no delay in submitting the same.

May, therefore, if approved, property statements for the financial years 2018-20 (2018-19 & 2019-20) of Sri Gajendra Kumar, District & Sessions Judge, Banda be laid before Hon'ble Mr. Justice Rajesh Singh Chauhan, Administrative Judge, Banda Judgeship for His Lordship's kind perusal and orders?
