In this connection, it is submitted that as per the statement of movable and immovable properties for the financial years 2014-16 (2014-15 & 2015-16) of the officer concerned, details of income, deduction, savings investment and expenditure made by him are given below:

(1) In the financial years 2014-16 (2014-15 & 2015-16), Gross income (salary, interest on bank deposits, redeemed of mutual funds and dividends from mutual funds) Rs. 30,16,422/- and total deductions/savings/ investment against GPF, GIS, PPF, Income Tax, LIC, Oasis Realtech Investment (house) deposits, Amrapali Adarsh Awas Yojna investment deposits and the balance of his savings bank account(s) is also enhanced by Rs.3,30,542/- in this financial year from previous year's balance, total of which is Rs.25,12,114/-. Thus, a sum of Rs.5,04,308/- was therefore available with him to meet out the household expenditure of his family consisting three members in the both of the financial year.

In this connection, it is submitted that the Officer has already submitted his property statement of the financial year 2012-14 (2012-13 & 2013-14) offline against Misc. file and same has been moved before Hon'ble Mr. Justice Rajan Roy, Administrative Judge, Bulandshahar for His Lordship's kind perusal and orders..

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit his property statement for the financial years 2014-16 (2014-15 & 2015-16) in its next financial year i.e., 2016-17 upto March 2017. He has submitted movable and immovable property statements of the financial year 2014-16 (2014-15 & 2015-16) vide online dated 31.08.2020. As such, there is delay in submitting the same. In this regard, officer has stated that's due to property statement for F.Y. 2014-15 sent earlier vide Dispatch no.1641 dt.19-8-15 from Distt.Sitapur is being furnishing again by clubbing statements of F.Y. 2014-15 and F.Y.2015-16 together as per instructions given in online objections.
