May kindly see the property statement online received from Sri Yadavendra Singh, Additional District & Sessions Judge, Bulandshahar regarding submission of statement of movable and immovable properties acquired/held by him or any member of his family of the financial years 2016-18 (2016-17 & 2017-18) in the prescribed proforma respectively to this Hon'ble Court for kind perusal and information as required by the Hon'ble Court.

In this connection, it is submitted that as per the statement of movable and immovable properties for the financial years 2016-18 (2016-17 & 2017-18) of the officer concerned, details of income, deduction, savings investment and expenditure made by him are given below:

(1) In the financial years 2016-18 (2016-17 & 2017-18), Gross income (salary, interest on bank deposits, mutual fund dividend and redeemed mutual funds) Rs. 32,46,245/- and total deductions/savings/investment against GPF, GIS, PPF, Income Tax, LIC, Oasis Realtech (house) Investment deposits, Car loan EMI is Rs.17,82,871 . Thus a sum of Rs. 14,63,374/- was therefore available with him to meet out the household expenditure of his family consisting of three members in the financial year 2016-18 (2016-17 & 2017-18) and the balance of his savings account is also decreased for Rs.1,95,709/- this financial year from previous year balance.

In this connection, it is submitted that the Officer has already submitted his property statement of the financial year 2014-16 (2014-15 & 2015-16) online against case id-P00006512020 and same has been moved before Hon'ble Mr. Justice Rajan Roy, Administrative Judge, Bulandshahar for His Lordship's kind perusal and orders..

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit his property statement for the financial years 2016-18 (2016-17 & 2017-18) in its next financial year i.e., 2018-19 upto March 2019. He has submitted movable and immovable property statements of the financial year 2016-18 (2016-17 & 2017-18) vide online dated 04.09.2020. As such, there is delay in submitting the same. In this regard, officer stated that's due to data collection of data from various sources like various Bank accounts pending in different districts being operated manually, Mutual Funds, Income Tax deptt. etc. Moreover some delay has also been caused due to inconvenience in filling statement online due to lack of Internet connectivity. For the above reasons, officer most humbly pryaed to Hon'ble Court to condone the delay in in furnishing the movable and immovable property statement for financial years 2016-18 together in the prescribed format.

May, therefore, if approved, property statements for the financial years 2016-18 (2016-17 & 2017-18) of Sri Yadavendra Singh, Additional District & Sessions Judge, Bulandshahar be laid before Hon'ble Mr. Justice Rajan Roy, Administrative Judge, Bulandshahar for His Lordship's kind perusal and orders?
