In the financial year 2018-20 (2018-19 & 2019-20), his Total income is Rs. 36,96,494/- (Gross Salary – 35,82,656, Redemption of Equity fund – 1,00,000 and Maturity of NSC - 13838) and total deductions/savings/investments against NPS, GIS, Income Tax, L.I.C., P.P.F., repayment of car loan, Reliance return plan, Reliance endownment plan, ICICI Prudential Focused Blue chip Equity Fund is Rs. 19,58,758/- (including enhancement of Rs. 1,87,950/- in his Saving Bank account against the balance of the previous year). In this connection, it is submitted that the officer has already submitted his property statements offline for the financial year 2016-18 which was seen by Hon'ble Mr. Justice Pankaj Naqvi, the then Administrative Judge, Pilibhit in the Misc. file of the officer.

It is further submitted that as per policy/Court's Circular letter, the officer has to submit his property statements for the financial year 2018-20 (2018-19 & 2019-20) in its next financial year i.e., 2020-21 upto March 2021. He has submitted movable and immovable property statements for the financial years 2018-20 (2018-19 & 2019-20) vide his online application dated 01.01.2021. As such, there is no delay in submitting the same from the part of the officer.
