May kindly see the reply received online from Sri Vineet Chaudhary, the then Additional District & Sessions Judge, Gautambudh Nagar presently posted as Additional District & Sessions Judge, Hathras, in compliance of order of Hon'ble Mr. Justice Ramesh Sinha, the then Administrative Judge, Gautambudh Nagar in the matter of property statement, communicated to the officer.

In this connection, it is submitted that earlier the officer had submitted his movable & immovable property statements for the financial years 2016-17 & 2017-18 which were put up before Hon'ble Administrative Judge, Gautambudh Nagar through detailed online office note dated 19.02.2021 on which His Lordship has been pleased to pass the following online order dated 27.02.2021:

" Office has reported that Sri Vineet Chaudhary, Additional District & Sessions Judge, Gautambuddha Nagarhas submitted his property statements for the financial years 2016-17 and 2017-18 vide online application dated 28.09.2020 which were due to be submitted upto the end of the financial year 2018-19 i.e. upto March, 2019 and, therefore, there is delay in submitting the property statements from the part of the Officer.

C.L. No. 16/IV-h-16/Admn(A) dated 13th May, 2004 (in continuation of Court's Circular Letter No. 63/IV-h/16/Admn-A Dated 10.12.1998) relates to submission of statements of movable and immovable property to be submitted by all the judicial officers. The Circular Letter provides "the judicial officers be now required to submit property statement at the time of entering the service and thereafter at the interval of two financial years i.e. in every third financial year."

The Circular letter further imperatively requires all Judicial Officers posted in judgeship to ensure strict compliance of the above circular Letter of the Hon'ble Court in the matter. Submission of property statement is not a mere farce formality but is a predominant requirement of Government Servants Conduct Rules.

'n,

Let the officer explain the delay in filing the statements.

Office shall forthwith place the property statements of the officer after receipt of his explanation."

The order of the Hon'ble Court had been communicated to the officer concerned on 04.03.2021.

In reply of the Hon'ble Court's order, officer concerned has attached medical papers & explanation, in which he has stated that that " his wife Smt. Amita Chaudhary was diagnosed with cancer in the first week of July, 2018, which is under treatment of AIIMS, New Delhi. Her surgery had been done on 31.07.2018, after that chemothearpy treatment provide to her. Presently she is supervision under which various tests are conducted at regular intervals. He has been lot of mental stress due to the said disease of her wife. He is also apologised for not submitting the aforesaid statements within time due to busy in excess work & mental stress. He has not any intention to hide any facts."

May, therefore, if approved, property statement of the financial years 2016-17 & 2017-18 alongwith reply of Hon'ble Court's Order as desired by the Hon'ble Court in the matter, furnished by Sri Vineet Chaudhary, the then Additional District & Sessions Judge, Gautambudh Nagar presently posted as Additional District & Sessions Judge, Hathras be laid before Hon'ble Mr. Justice Manish Mathur, Administrative Judge, Hathras for His Lordship's kind perusal and orders?
